ARTICLES OF ORGANIZATION

Pursuant to the provisions of §10-12-1, et seq., Code of Alabama (1975) ("*the Alabama Limited Liability Company Act*") the undersigned hereby adopts the following Articles of Organization.

ARTICLE ONE

The name of the Limited Liability Company is: **BRUCE ENGINEERING, LLC.**

ARTICLE TWO

The duration of the Limited Liability Company is perpetual.

ARTICLE THREE

The Limited Liability Company has been organized for the following purposes:

- a. To engage, generally, in the business of engineering and consulting; and
- b. To engage in any activity necessary to carry out the purposes stated hereinabove.

ARTICLE FOUR

The remaining member or members of the Limited Liability Company shall have the right to continue business after the termination of membership of any member of the Limited Liability Company.


ARTICLE EIGHT


