Subject to easements, restrictions and reservations of record.

TO HAVE AND TO HOLD unto the said Grantee and her heirs and assigns, forever.

AND THE GRANTOR DOES HEREBY COVENANT with the Grantee, except as above-noted, that, at the time of the delivery of this Deed, the premises were free from all encumbrances made by her, and that she will warrant and defend the same against the lawful claims and demands of all persons claiming by, through, or under them, but against none other.
