

**Articles of Organization – Member Managed**

**ARTICLES OF ORGANIZATION OF C + C customs, L.L.C.**

Pursuant to the Provisions of Sections 10-12-1, *et seq.* of the *Code of Alabama* (1975), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

**ARTICLE I**

*Name*

The name of the limited liability company is **C + C customs, L.L.C.** (the “Company”).

**ARTICLE II**

*Duration*

The Company’s duration shall be perpetual from the date of organization, unless it is dissolved and its affairs wound up prior to that date in accordance with the Alabama Limited Liability Company Act (the “Act”).

**ARTICLE III**

*Purposes*

The purposes for which the Company is formed are:

- (a) To engage in residential and/or commercial property repairs, restoration, or modifications as requested;
- (b) To act as agent, representative, or receiver of any person, firm, corporation, or government entity or instrumentality in respect to any lawful undertaking or transaction;
- (c) To purchase, take, receive, lease or otherwise acquire, own, hold, improve, use and otherwise deal in or with, real or personal property, or any interest therein, wherever situated, and to sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of real or personal property, or any interest therein;
- (d) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interest in, or obligations of, corporations, associations, partnerships,

limited liability companies, individuals, or direct or indirect obligations of governmental entities or of any instrumentality thereof;

- (e) To lend money, invest and reinvest its funds and take and hold real and personal property as security for the payment of funds so loaned or invested; and
- (f) To engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act.

#### ARTICLE IV

##### *Registered Office; Registered Agent*

The location and street address of the initial registered office of the Company shall be 3242 Highway 51, Wilsonville, AL 36186, and its registered agent at such address shall be Ricky J. Cloutier II.

#### ARTICLE V

##### *Initial Members*

The names and addresses of the initial members are:

#### ARTICLE VI

##### *Admission of Additional Members*

Upon the unanimous written consent of the members, the Company may permit the admission of additional members and the terms and conditions of their admission shall be as set forth in the Company's Operating Agreement.


#### ARTICLE VII

##### *Continuation of Business*


