
CERTIFICATE OF APPOINTMENT

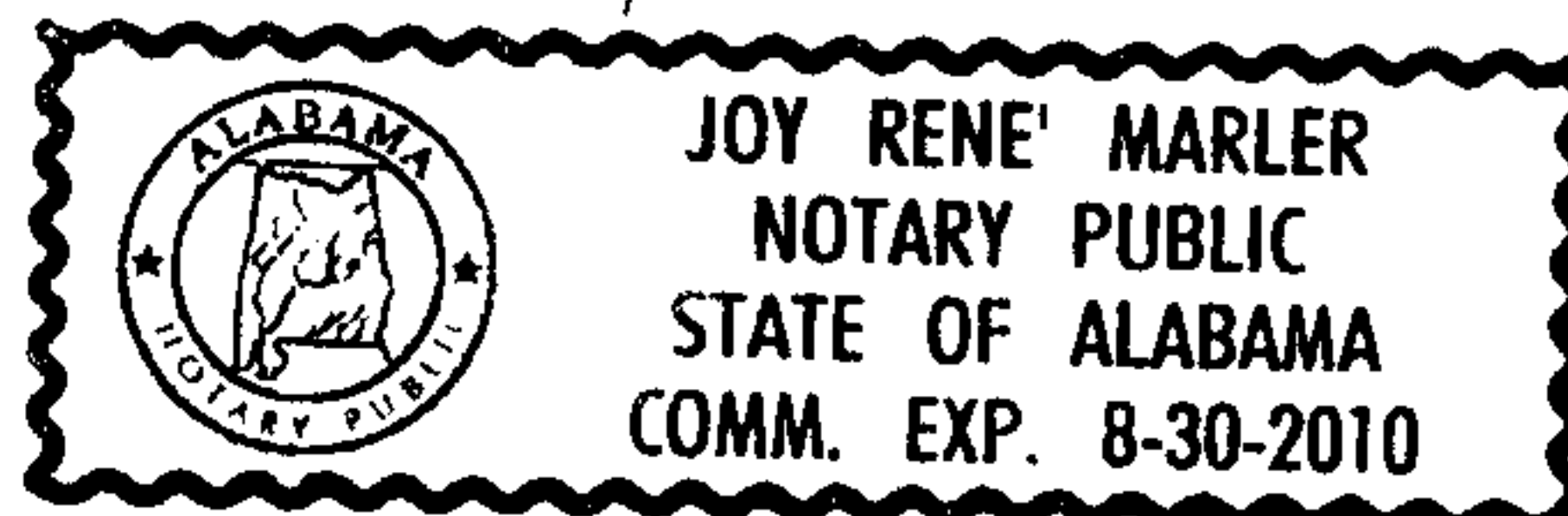


