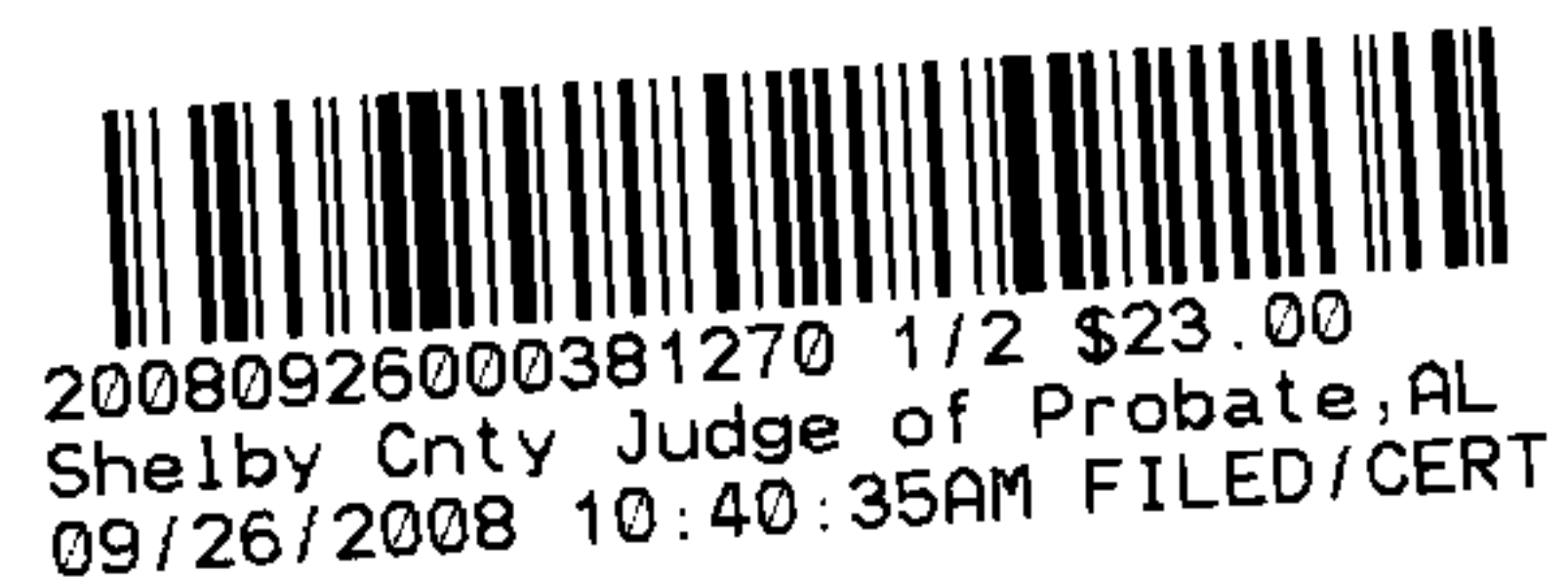

POWER OF ATTORNEY
