KNOW ALL MEN BY THESE PRESENTS: That Lloyd Edward Fuller, Jr. did, on to-wit, the March 14, 2005, execute a mortgage to Secured Funding Corp., which mortgage is recorded in Instrument # 20050510000223230 and re-recorded in Instrument # 20080619000251740; said mortgage was transferred and assigned to MVB Mortgage Corporation as recorded in Instrument # 20050210000223240 et seq., in the Office of the Judge of Probate of Shelby County, Alabama; and

WHEREAS, default was made in the payment of the indebtedness secured by said mortgage and the said MVB Mortgage Corporation did declare all of the indebtedness secured by said mortgage due and payable and did give due and proper notice of the foreclosure of said mortgage, in accordance with the terms thereof, by publication in The Shelby County Reporter, a newspaper of general circulation published in Shelby County, Alabama, in its issues of September 24, October 1, 8, 2008; and

WHEREAS, on the October 13, 2008, the day on which the foreclosure sale was due to be held under the terms of said notice, at 12:15 o'clock a.m./p.m., between the legal hours of sale, said foreclosure sale was duly and properly conducted, and MVB Mortgage Corporation did offer for sale and did sell at public outcry, in front of the courthouse door of the Shelby County, Alabama, Courthouse in the City of Columbiana, Alabama, the property hereinafter described; and


WHEREAS, the highest and best bid for cash obtained for the property described in the aforementioned mortgage was the bid of MVB Mortgage Corporation, in the amount of One Hundred Thousand Four Hundred Sixty-Nine Dollars and No Cents (\$100,469.00), which sum the said MVB Mortgage Corporation offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to the said MVB Mortgage Corporation; and






