Subordination Agreement

THIS AGREEMENT is made and entered into on this **29** day of **October 2008**, by Regions Bank (hereinafter referred to as "Regions") in favor of **REGIONS BANK**, its successors and assigns (hereinafter referred to as "Lender").

RECITALS

Regions loaned to **MICHAEL G. CONNOLLY, JR AND SUSAN P. WILKENS** (the "Borrower") whether one or more) the sum of **\$358,000.00**. Such loan is evidenced by a note dated **05/24/2007**, executed by Borrower in favor of Regions, which note is secured by a mortgage, deed of trust, security deed, to secure debt, or other security agreement recorded **06/14/2007**, in Record Book **INST #20070614000280010**, at Page **N/A**, amended in Record Book **N/A** at Page **N/A** in the public records of **SHELBY COUNTY ALABAMA** (the "Regions Mortgage").
