

ARTICLES OF ORGANIZATION OF NATIVE RESOURCES, LIMITED LIABILITY COMPANY/LLC

Pursuant to the Provisions of Sections 20-12-1, *et seq.* of the Code of Alabama (1975), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

ARTICLE I

The name of the limited liability company is NATIVE RESOURCES, Limited Liability Company/LLC. (The "Company").

ARTICLE II

Duration

The Company shall have a perpetual duration from the date of organization in perpetuity unless it is dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Act (the "Act:").

ARTICLE III

Purposes

The purpose for which the Company is formed are:

- (a) Provide products for ceremonial use.
- (b) The Company may also engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act. The Company shall have the authority to do all things necessary or convenient to accomplish its purposes and operate the business as described in the Articles.

ARTICLE IV

Registered Office; Registered Agent

The location and street address of the initial registered office of the Company shall be 873 1st Street north, Alabaster Al. 35007 and the registered agent shall be Steve Scott.

Upon the unanimous written consent of the members, the Company may permit the admission of additional members and terms and conditions of their admission shall be set forth in the Company's Operating Agreement.

ARTICLE VII

Cessation of Membership

The cessation of membership of one of more members will not result in the dissolution of the Company.


ARTICLE VIII
