KNOW ALL MEN BY THESE PRESENTS: That Diana M. Sprayberry and Charles N. Sprayberry, husband and wife did, on to-wit, the February 4, 2005, execute a mortgage to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for First Magnus Financial Corporation, which mortgage is recorded in Instrument# 2005021000067470; said mortgage was transferred and assigned to Bank of America NA as trustee for WaMu Mortgage Pass-Through Certificates Series 2005-2Trust as recorded in Instrument # 20081212000464480 et seq., in the Office of the Judge of Probate of Shelby County, Alabama; and


