Subject to mineral and mining rights if not owned by Grantor.

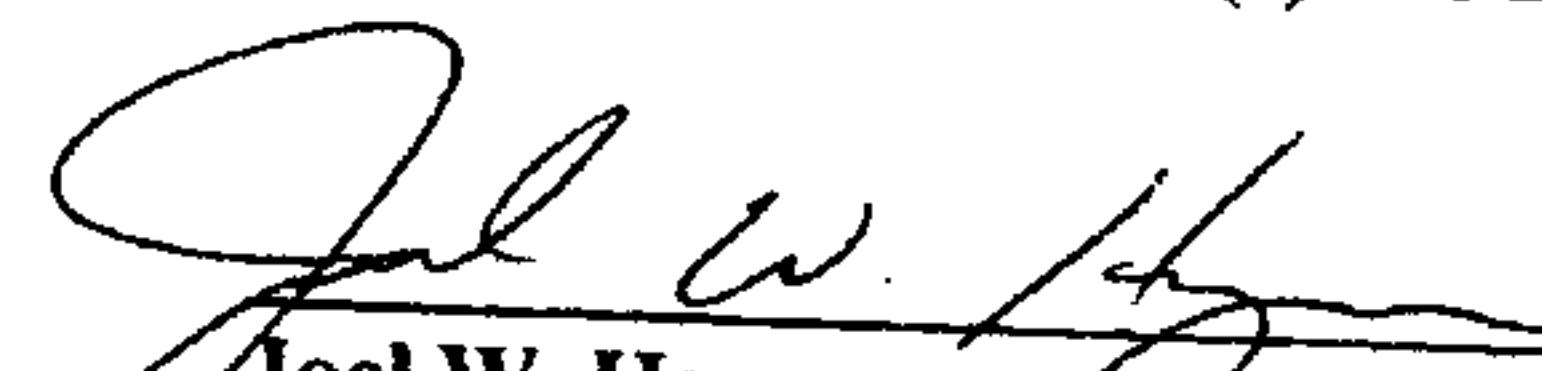

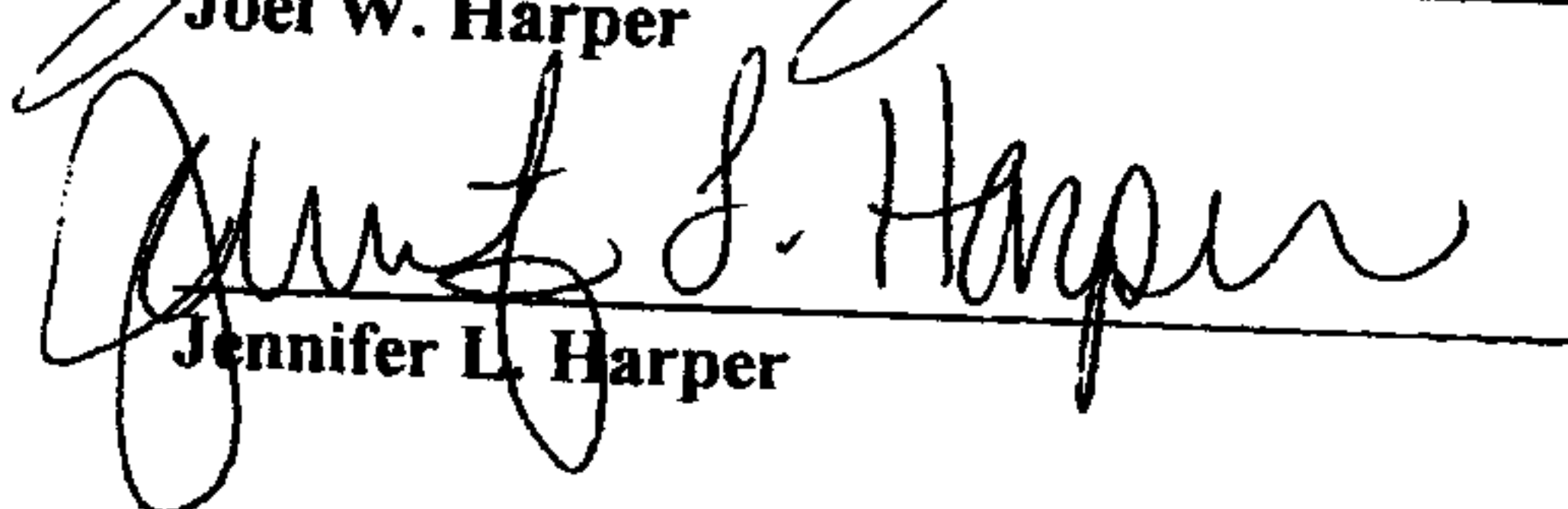
\$149,400.00 of the purchase price recited above was paid from mortgage loan closed simultaneously herewith.
