FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 5th day of August, 2005, Monica Muchangi, unmarried, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Choice Capital Funding Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20050822000429960, said mortgage having subsequently been transferred and assigned to The Bank of New York Trust Company, N.A. as successor to JP Morgan Chase Bank, N.A. as Trustee, by instrument recorded in Instrument Number: 20070226000086630, in the aforesaid Probate Office ("Transferee"); and


