# AMENDMENT TO ARTICLES OF ORGANIZATION OF EAGLE LANDING, LLC

Pursuant to Code of Alabama, Section 10-12-11, the undersigned members of Eagle Landing, LLC, a limited liability company organized and existing under the laws of the State of Alabama (the "Company"), hereby submit the following:

- 1. The name of the Company is Eagle Landing, LLC.
- 2. The Articles of Organization of the Company were filed in the office of the Judge of Probate of Shelby County, Alabama, on June 20, 2005.
  - 3. The Articles of Organization of the Company are hereby amended as follows:
- I. Article II of the Articles of Organization is hereby deleted in its entirety, and there is substituted in lieu thereof the following:

## "ARTICLE II

## **DURATION**

The existence of the Company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and shall be dissolved upon the earlier to occur of (i) the written consent of all the members to dissolve the Company; (ii) as provided in the operating agreement of the company; or (iii) as may be required under the Act."

II. Article V of the Articles of Organization is hereby deleted in its entirety, and there is substituted in lieu thereof the following:

# "ARTICLE V

## INITIAL MEMBERS

III. Article VII of the Articles of Organization is hereby deleted in its entirety, and there is substituted in lieu thereof the following:

#### "ARTICLE VII

# ADMISSION OF NEW MEMBERS

The Company shall admit additional members only upon the terms and conditions set forth in the operating agreement."

IV. Article VIII of the Articles of Organization is hereby deleted in its entirety, and there is substituted in lieu thereof the following:

## "ARTICLE VIII

# **CONTINUATION OF BUSINESS**


The cessation of membership of one or more members will result in dissolution of the Company if there are no remaining members, unless the legal existence and business of the Company is continued and one or more new members is appointed in the manner provided in the operating agreement."

V. Article IX of the Articles of Organization is hereby deleted in its entirety, and there is substituted in lieu thereof the following:
