

# Amended and Restated Articles of Incorporation

Of

Taking Jesus to the Streets Ministries, Inc.

#### Article I

# Name/Registered Office

The name of the corporation shall be Taking Jesus to the Streets Ministries, Inc.

The registered agent is Glenn (Scott) McKinney and the office is located at 3028

Spruce Drive, Helena, AL 35080.

#### Article II

#### Purpose

This corporation is organized exclusively as a church to perform church activities.

This corporation will hold church services, engage in preaching, evangelism,

praise and worship, youth ministry, homeless ministry, street ministry, perform


weddings and burials, and any other activities that are a normal part of

ministering the gospel of Jesus Christ.

#### Article III

#### **Exemption Requirements**

1. The corporation shall not afford pecuniary gain, incidentally or otherwise to its members. No part of the net earnings of this corporation shall inure to the benefit of any member of the corporation, except that reasonable compensation may be paid for services rendered to or for the corporation



- affecting one or more of its purposes. Such net earnings, if any, of this corporation shall be used to carry out the nonprofit corporate purposes set forth in Article II above.
- 2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
- 3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities no permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended.

#### **Article IV**


#### Duration

The duration of the corporate existence shall be perpetual.

#### Membership

The corporation shall have one or more classes of members. The eligibility, rights, and obligations of the members shall be determined by the organization's bylaws.

#### **Article VI**


#### **Personal Liability**


