## ARTICLES OF ORGANIZATION

### OF

### BSR PARKING, LLC

The undersigned, for the purpose of forming a limited liability company under Title 10, Chapter 12 of the Code of Alabama (1975), as amended (the "Alabama Limited Liability Company Act"), hereby file the following Articles of Organization with the probate judge of the county in which the initial registered agent of the limited liability company will be located and affirm that the facts stated in these Articles of Organization are true and correct:

#### ARTICLE I

The name of the limited liability company is BSR Parking, LLC (the "Company").

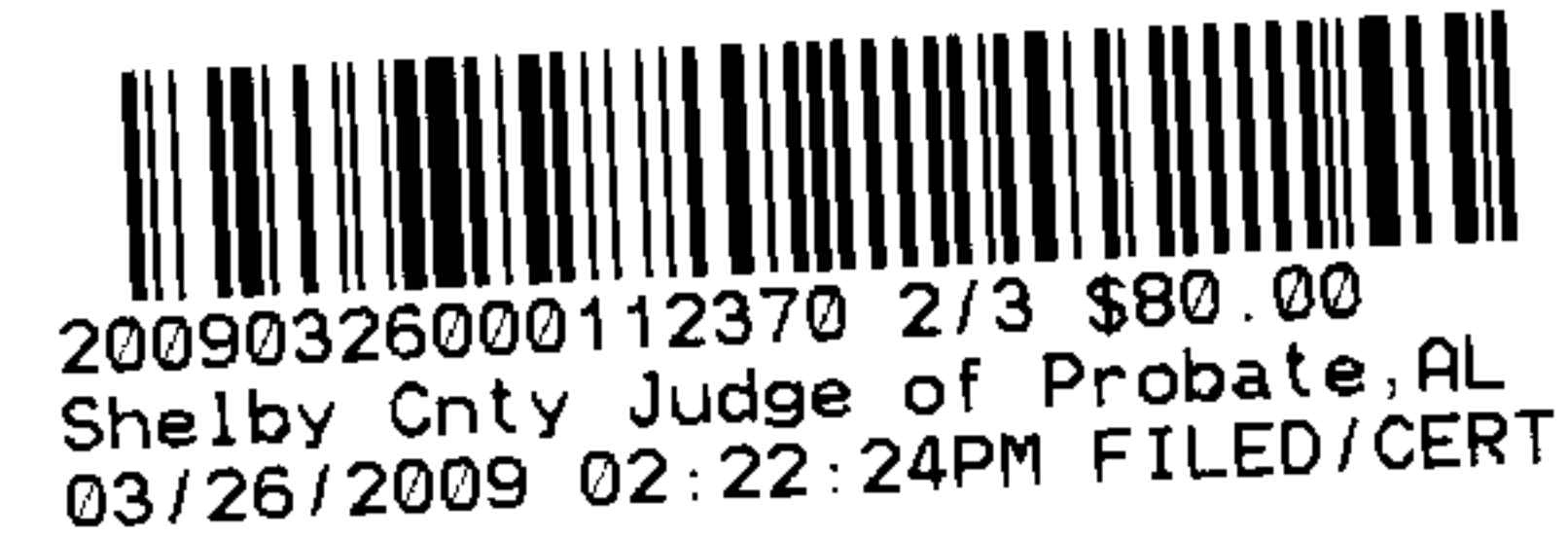
#### ARTICLE II

The period of duration of the Company shall be perpetual beginning on the date of filing of these Articles of Organization with the Office of the Probate Judge for Shelby County, Alabama; provided, however, that the Company shall be dissolved (a) as provided in the Operating Agreement, as amended from time to time, or (b) as may be required by the Alabama Limited Liability Company Act.

#### ARTICLE III

The purposes for which the Company is organized are as follows:

- (a) To engage in the transaction of any or all lawful business for which limited liability companies may be organized under the laws of the State of Alabama.
- (b) To enter into, perform and carry out contracts and agreements necessary, appropriate or incidental to the accomplishment of the purposes of the Company; and
- (c) To do any other acts and things which may be necessary, appropriate or incidental to the carrying out of the business and purposes of the company, subject to the terms and conditions of the Operating Agreement.



#### ARTICLE IV

The location and mailing address of the initial registered office of the company shall be 270 Forest Lakes Drive, Sterrett, Alabama 35147. The initial registered agent for service of process at the foregoing address shall be J. Robert Adams III.

#### ARTICLE V

The name and mailing address of the initial membes of the company is as follows:

#### ARTICLE VI

The members of the Company shall have the right to admit additional members to the Company upon the unanimous written consent of the members of the Company.

#### ARTICLE VII

The members of the Company shall have the right to continue the business of the Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member of the Limited Liability Company if (i) there is at least one remaining member; or (ii) there is no remaining member, and the holders of all the financial rights in the Company agree in writing, within 90 days after the cessation of membership of the last member, to continue the legal existence and business of the Company and to appoint one or more new members.

## ARTICLE VIII

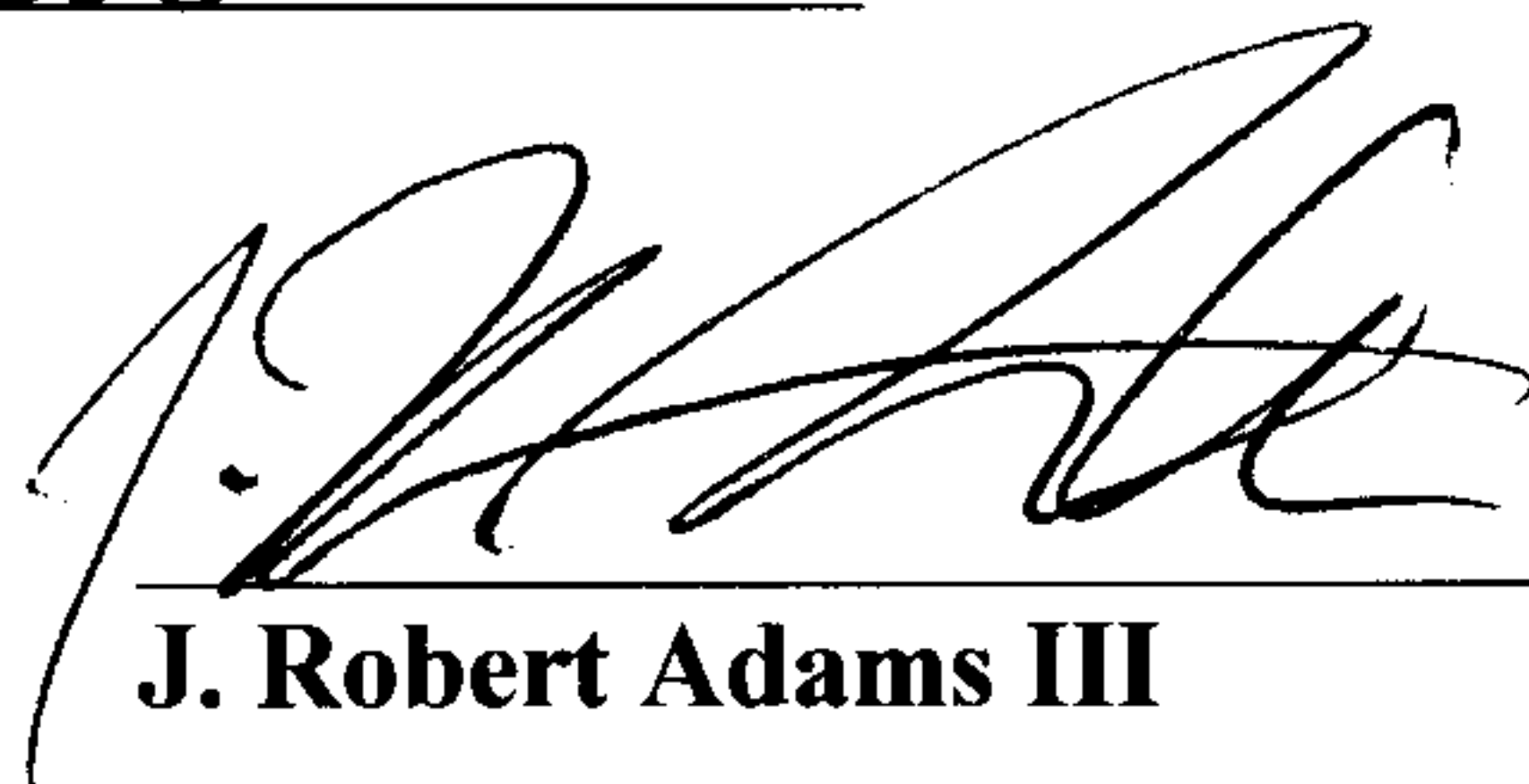
The Company shall be managed by a Manager or Managers. The names and mailing address of the Managers who are to serve until their successors are elected and begin serving are:
