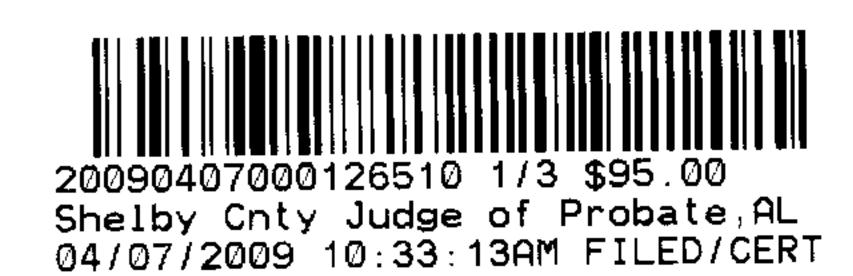
ARTICLES OF INCORPORATION

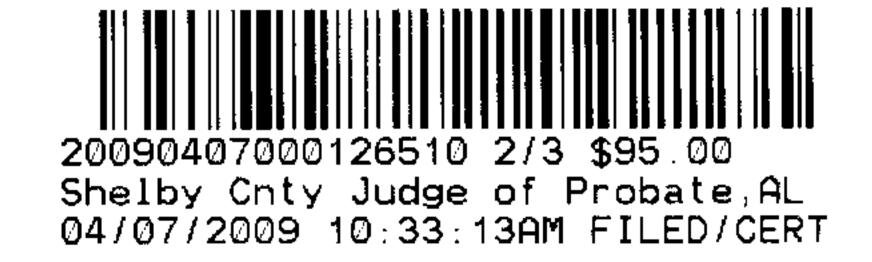

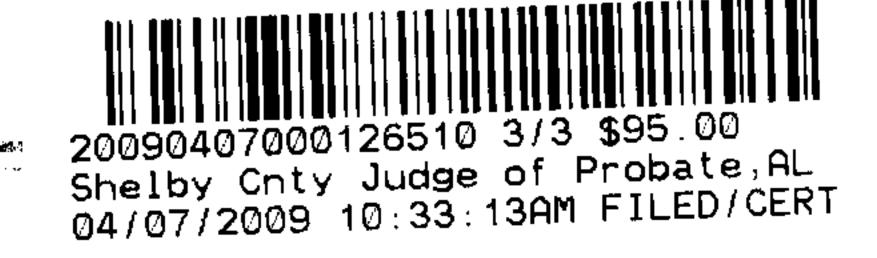
