That in consideration of One Hundred Eighty-nine Thousand, Five Hundred and no/100-----
(\$189,500.00) Dollars

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,

(herein referred to as grantors) do grant, bargain, sell and convey unto

Janet L. Wheeler and Mary E. Wheeler

(herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in

Shelby County, Alabama to-wit:

Lot 42, according to the Survey of Amended Map of Greystone
Highlands, Phase 2, as recorded in Map Book 19, Page 25,
