This Subordination Agreement made and entered into on this the 14<sup>th</sup> day of April, 2009, by and between: ALABAMA TELCO CREDIT UNION., as party of the First Part and FIRST FEDERAL BANK, party of the Second Part.

## WITNESSETH:

That, Whereas, FREDDIE JACK WILLIAMSON, has an outstanding lien in favor of: ALABAMA TELCO CREDIT UNION dated the 25<sup>th</sup> day of JUNE, 2008, and recorded in Instrument 20080722000294410 in the Probate Office of Shelby County, Alabama, on certain real estate described therein to secure an indebtedness of \$10,000.00.

Whereas, FREDDIE JACK WILLIAMSON has/have made an application to the Party of the Second Part for a loan in the sum of \$106,000.00 and said Party of the Second Part is willing to make said loan to the said, provided they furnish it with a mortgage on the lands described in the aforesaid lien, and the said Party of the First Part subordinate the above-described lien and make the same second and subservient to the mortgage of FIRST FEDERAL BANK.

Now, Therefore, in consideration of the premises and the further consideration of the sum of \$1.00, cash, in hand paid, the Party of the First Part by the Party of the Second Part, the receipt of which is hereby acknowledge, the said Party of the First Part does hereby agree that the lien of, ALABAMA TELCO CREDIT UNION dated the 25<sup>th</sup> day of JUNE, 2008, recorded in Instrument 20080722000294410 in the Probate Office of Shelby County, Alabama, shall be subordinate to the mortgage of FIRST FEDERAL BANK dated 20090424000152110 and recorded 20090424000152110 in the Probate Office of Shelby County Alabama.

IT IS FURTHER agreed that should FREDDIE JACK WILLIAMSON default in the payments under the terms of the real estate mortgage to Party of the Second Part, the said Lender agrees to notify Party of the First Part of said default prior to taking legal action.
