

**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporators of a corporation under the Alabama Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

FIRST: The name of the Corporation is "T & J SUPPLY COMPANY, INC.".

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized is the transaction of any and all lawful business for which corporations may be organized under the Alabama Business Corporation Act, including but not limited to engaging in the general business of wrought iron door units, and other related services.

FOURTH: The aggregate number of shares which the corporation shall have the authority to issue is 100 shares, having a par value of \$1.00 per share.
