ARTICLES OF ORGANIZATION OF MENAWA HOMES, LLC

We, the undersigned, desiring to form a Limited Liability Company pursuant to Section 10-12-1, et seq., of the Code of Alabama, hereby adopt the following Articles of Organization:

- 1. The name of the Limited Liability Company is MENAWA HOMES, LLC.
- 2. The existence of the Limited Liability Company shall commence on the date of the filing of the Articles of Organization in the Office of the Judge of Probate of Shleby County, Alabama, and shall continue in perpetuity, provided, however, that the Limited Liability Company shall be dissolved prior to such date (a) upon the written consent of the Members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Act.
 - 3. The purposes for which this Limited Liability Company is organized are:
