FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 4th day of February, 2005, Anwar J. Caldwell and Kimberly Caldwell, executed that certain mortgage on real property hereinafter described to Ameriquist Mortgage Company, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. # 20050225000090660, said mortgage having subsequently been transferred and assigned to JPMC Specialty Mortgage, LLC ("Transferee"); and
