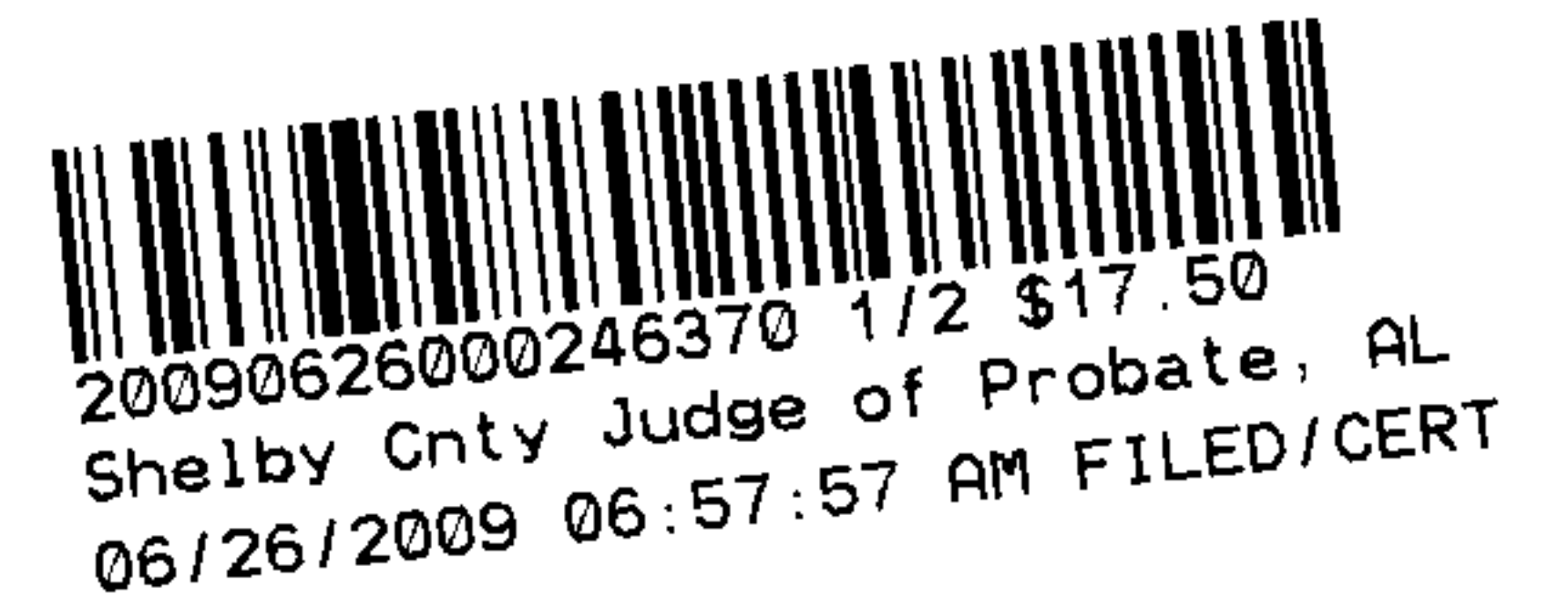

TO HAVE AND TO HOLD, to the said Grantee, his/her heirs and assigns forever.


