

## CERTIFICATE OF TRUST


The undersigned Trustee hereby certifies the following:

7. The Trust has not been revoked and there have been no amendments limiting the powers of the Trustees over trust property.

All persons relying on this document regarding the Trustees and their powers over trust property shall be held harmless for any resulting loss or liability from such reliance. 
