

AUCTIONEER'S DEED

WHEREAS, ADAM MICHAEL BRIDGES and BELLINI BRIDGES, husband and wife and KENNETH BENOSKIE and SARAH A. BENOSKIE, Husband and Wife executed a mortgage to Mortgage Electronic Registration Systems, Inc. 
WHEREAS, default was made in the payment of said indebtedness described in and secured by said mortgage; and
