**ARTICLES OF ORGANIZATION  
OF  
GREYSTONE INN & SUITES, LLC**

The undersigned, for the purpose of forming a limited liability company under Title 10, Chapter 12 of the Code of Alabama (1975), as amended (the “Alabama Limited Liability Company Act”), hereby file the following Articles of Organization with the probate judge of the county in which the initial registered agent of the limited liability company will be located and affirm that the facts stated in these Articles of Organization are true and correct:

ARTICLE I

The name of the limited liability company is GREYSTONE INN & SUITES, LLC (hereinafter referred to as the “Company”).

ARTICLE II

The period of duration of the Company shall be from the date of filing of these Articles of Organization with the Office of the Probate Judge for Shelby County, Alabama until the first to occur of the following:

- (a) Dissolution of the Company pursuant to the laws of the State of Alabama or the Operating Agreement of the Company, as in effect from time to time; or
- (b) Upon the written unanimous consent of all the members of the Company.

ARTICLE III

The purpose for which the Company is organized is to engage in the transaction of any or all lawful business for which limited liability companies may be organized under the laws of the State of Alabama.

ARTICLE IV

The location and mailing address of the initial registered office of the Company shall be 100 Metro Parkway, Pelham, Alabama. The initial registered agent for service of process at the foregoing address shall be Edwin B. Lumpkin, Jr.

ARTICLE V

The name and mailing address of the initial member of the Company is as follows:

ARTICLE VI

The name and mailing address of the Organizer of the Company is Edwin B. Lumpkin, Jr., 100 Metro Parkway, Pelham, Alabama 35124.

ARTICLE VII

The members of the Company shall have the right to admit additional members to the Company upon the unanimous consent of all of the members of the Company.

ARTICLE VIII

The members of the Company or the holders of all the financial rights in the Company shall have the right to continue the business of the Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member of the Company if they agree in writing within 90 days after the cessation of membership of the last member, to continue the legal existence and business of the Company and to appoint one or more new members.

ARTICLE IX


The Company shall be managed by its members.

of the Company, as provided in the Alabama Limited Liability Company Act.
