
AFFIDAVIT OF ASSIGNMENT

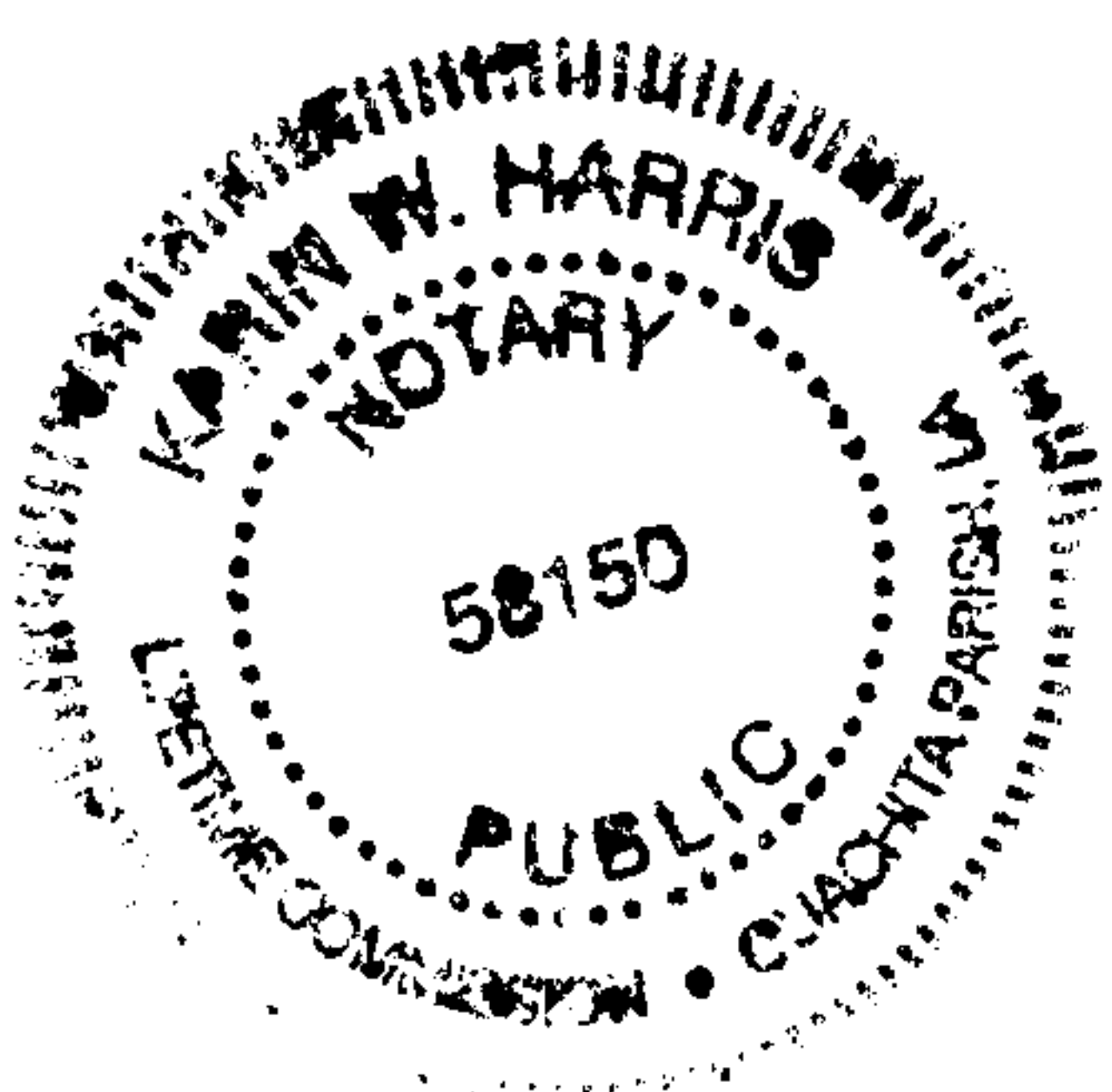
