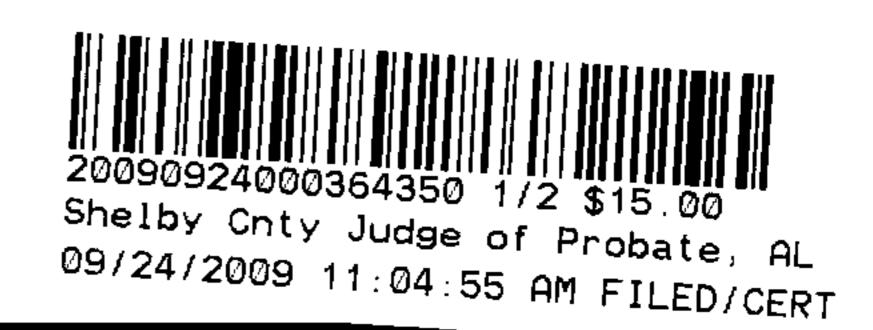
## WARRANTY DEED

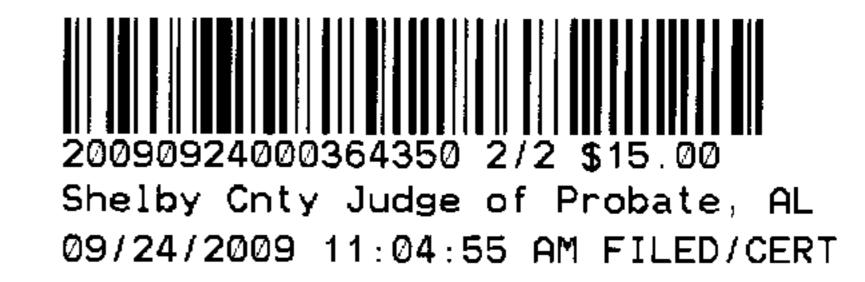
