THAT IN CONSIDERATION OF FORTY TWO THOUSAND and 00/100 DOLLARS (\$42,000.00) AND OTHER GOOD AND VALUABLE CONSIDERATION paid to the undersigned Grantor, in hand paid by the Grantee herein, the receipt of which is hereby acknowledged, **MAVERICK ENTERPRISES, LLC**, (herein referred to as Grantor), does grant, bargain, sell and convey unto **EDDIE HARRIS, a married man**, (herein referred to as Grantee), the following described real estate (herein referred to as the Property), situated in the State of Alabama, County of Shelby, to-wit:

**A part of the SE ¼ of the SW ¼ of Section 28, Township 21 South, Range 3 West, Shelby County Alabama, more particularly described as follows: Commence at the NW corner of the SE ¼ of the SW ¼ of Section 28, Township 21 South, Range 3 West, Shelby County, Alabama, and run East along the North line of said ¼, ¼ Section to the Eastern boundary line of Southern Railroad right-of-way to the point of beginning of herein described property; thence run East along the North line of ¼, ¼ Section a distance of 267.4 feet; thence South a distance of 104.3 feet; thence West of Eastern right-of-way of Southern Railroad; thence along the Easterly line of said right-of-way to point of beginning; LESS AND EXCEPT the Westerly 15 feet for road right-of-way; ALSO an Easement described as follows: Commence at the NW corner of the SE ¼ of the SW ¼ of Section 28, Township 21 South, Range 3 West, and run in an Easterly direction along the North line thereof a distance of 50.00 feet to a point on the Easterly right-of-way of Southern Railway; thence turn right an angle of 101° 39' in a Southwesterly direction along said right-of-way a distance of 105.84 feet to a point of beginning; thence continue last described course for a distance of 112.0 feet, more or less, to a point on the Northeasterly right-of-way line of Shelby County Highway No. 17; thence turn left 21°10' in a Southeasterly direction along said highway right-of-way line a distance of 30.00 feet; thence turn left an angle of 148° 50' in a Northeasterly direction a distance of 140.00 feet; thence turn left an angle of 101° 39' in a Westerly direction a distance of 15.00 feet, more or less to the point of beginning.**


