**KNOW ALL MEN BY THESE PRESENTS,** That in consideration of the sum of **One Hundred Fifty Thousand Nine Hundred dollars and Zero cents ( \$150,900.00 )** paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, **David A. Lee and Kathy L. Lee, as husband and wife** (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto **Timothy P. Thomas and Britney N. Thomas as joint tenants with rights of survivorship** (hereinafter Grantees), all of my/our right, title and interest in the following described real estate, situated in **Shelby County, Alabama:**


Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.


