CORRECTIVE QUITCLAIM DEED





TO HAVE AND TO HOLD unto the said Grantee, her successors and assigns forever.

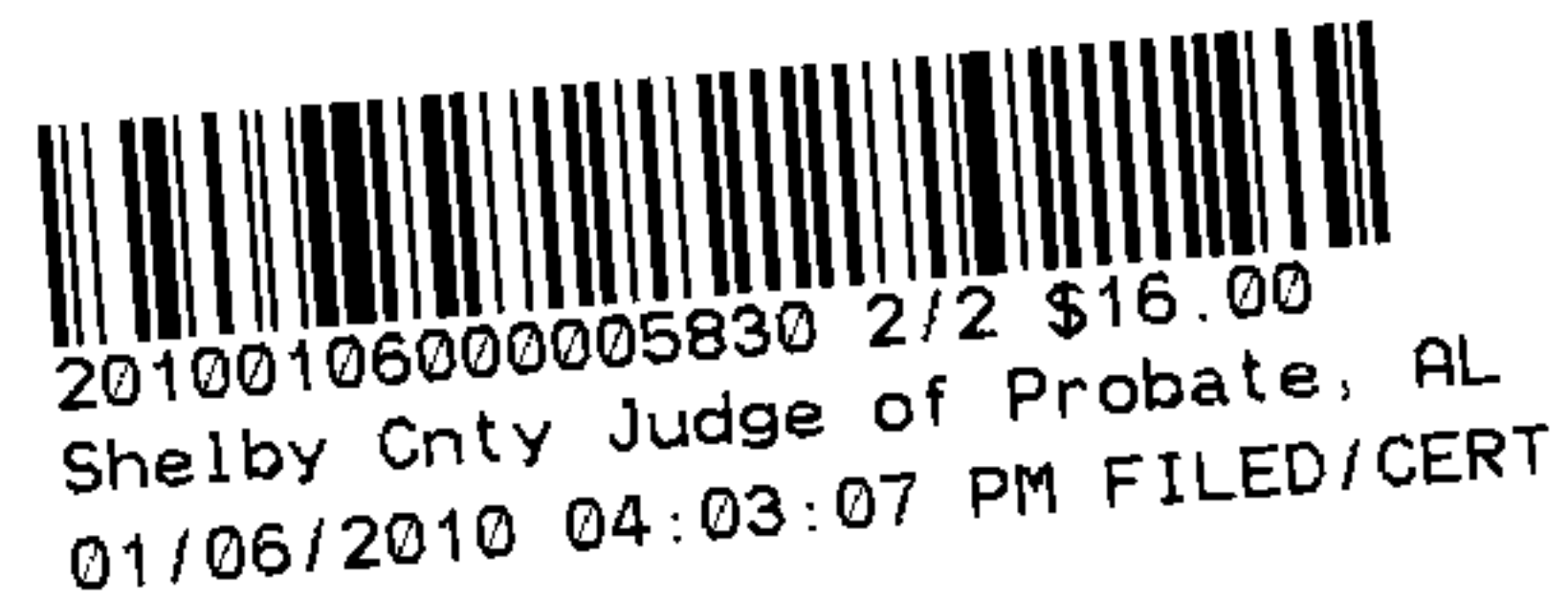
