
SPECIFIC DURABLE POWER OF ATTORNEY



KNOW ALL MEN BY THESE PRESENTS, that I, Barbara Macgirvin, have made, constituted and appointed, and by these presents do make, constitute and appoint, Eric Jantz, my true and lawful attorney-in-fact to act in, manage, and conduct only that purpose stated below for me and in my name, place and stead, and for my use and benefit, and as my act and deed, to do and to execute, or to concur with persons jointly interested with myself therein in the doing or executing of, all or any of the following acts, deeds, and executing of, all or any of the following acts, deeds, and things necessary to accomplish the following:

I specifically authorize and grant to my said attorney-in-fact full power and authority to do, take, and perform all and every act and everything whatsoever requisite, proper or necessary to be done in the purchase and mortgage of the property hereinafter described, as fully to all intents and purposes as I might or could do if personally present with full power to execute and sign my name to purchase the herein referenced property for a sales price of \$100,000.00 and a first mortgage with a principle balance of \$75,000.00 at an interest rate of 5.250% for a period of thirty years on said property to Regions Bank dba Regions Mortgage with full power of substitution or revocation, hereby ratifying and confirming all that my attorney-in-fact, or his substitute, shall lawfully do or cause to be done by virtue of this Power of Attorney and the rights and powers herein granted as to the following described property:
