
## DELEGATION OF POWERS BY PARENTS POWER OF ATTORNEY

(EFFECTIVE UPON EXECUTION OF THIS INSTRUMENT)

In accordance with Section 26-2A-7 of the Uniform Guardianship and Protective Proceedings Act, Code of Alabama 1975, I, Ju Hee Kim, the mother and primary custodian of Albert Ye (D.O.B. August 20th, 1997) and Andrew S. Ye (D.O.B March 24th, 1999), do hereby constitute and appoint Jeffrey Thomas Bonner and Catherine Christian Bonner GUARDIANS (attorneys-in-fact) of my children, Albert Ye and Andrew Ye, from the date this document is executed until July 31st, 2010. This delegation IS NOT INTENDED to permit an abrogation of my responsibilities as a parent, including child support. I agree to provide fifteen hundred dollars (\$1500) per month to the GUARDIANS named herein. This document is only meant as a temporary delegation of my parental powers, and in no way relieves me of the responsibility of my children. This document also DOES NOT terminate my parental rights.

The GUARDIANS shall have the custody and power to consent to the following:

- 1) General Power and Delegation: It is my intention, as the primary custodian of Albert and Andrew Ye, that the GUARDIANS shall have all powers of care, custody and control over property for my children. GUARDIANS shall have full power and authority over my above-mentioned children, including decisions regarding the health, support, education, or maintenance of them. GUARDIANS may take and perform all and every act and thing, whatsoever requisite, proper or necessary to be done, in the exercise of any of the rights and powers herein granted, as fully to all intents and purposes for the benefit of my children, as I might or could do if personally present, hereby ratifying and confirming all that the GUARDIANS lawfully do, or cause to be done, by virtue of this delegation of powers and the rights and powers herein granted.
- 1) <u>Power to Provide Health Care Services:</u> To provide medical attention and services for Albert Ye and Andrew Ye, including the choice of a physician and the choice of a hospital; to provide such other care, comfort, maintenance and support as GUARDIAN may deem necessary; to employ and discharge medical personnel,



including physicians, dentists, nurses and therapists as my GUARDIANS deem necessary for Albert and Andrew Ye's physical, mental and emotional well-being, and to pay such individuals, or any of them, reasonable compensation.

- 2) <u>Power of Access and Disclosure of Medical Records:</u> To request, receive and review any information, verbal or written, regarding my children's physical or mental health, including medical and hospital records, and to execute any releases or other documents that may be required in order to obtain such information, and to disclose such information to such persons, organizations, firms or corporations as my GUARDIANS shall deem appropriate.
- 3) <u>Power to Contract:</u> To enter into and perform contracts of any kind that may, in the opinion of GUARDIANS, be necessary or proper to be entered into on behalf of Albert and Andrew Ye.
- 4) <u>Provide Shelter:</u> To provide shelter at the GUARDIANS' personal residence currently located at:

RE: Letter in compliance with Alabama Relocation Statute

Sung-Joon,

I am writing this letter to follow up on our conversation we had over your most recent visit, and to comply with Alabama's Relocation Statute presented in our Final Judgment of Divorce. As you know, now that I have finished my Doctorate of Musical Arts, I have been given several enticing career opportunities. It is in the best interests of our children that I pursue these possibilities, so I can help provide Andrew and Albert with a more financially secure life. We both owe them this.

For this purpose, I have accepted a teaching position in Korea. As you know, the Korean school year is not in sync with the school year in the United States. My position begins in early March, but our children do not finish school here until May. As their primary custodian, I have decided that they will finish the school year here (neither will change schools), and then join me in Korea, or I will retrieve them in July 2010. I have had an attorney draft a Delegation of Parental Powers document in order for Jeff Bonner and his wife, Catherine, to properly care for Andy and Albert. THIS IS A TEMPORARY ARRANGEMENT. NEITHER YOUR PARENTAL RIGHTS NOR YOUR PARENTAL OBLIGATIONS ARE AFFECTED. Conversely, my parental rights and obligations also remain in tact. My attorney has advised me that your duty to support your children with monthly child-support payments remains unaffected. Your failure to continue with these payments would be contempt of court, and you could be required to return to the US to defend against such an action. The children will join me in Korea when they complete this school year. They will start the International School on time in August.
