That said Charles H. Fuller claims a lien upon the following property, situated in Shelby County, Alabama, to wit:

This lien is claimed, separately and severally, as to both the buildings and improvement thereon, and the said land.

That said lien is claimed to secure an indebtedness of \$25,000 with interest, from to wit this 6<sup>th</sup> day of January, 2010, for services rendered pursuant to contract including materials and labor for substantial repair of water damage, repair of heating and cooling, painting, landscaping, roof repair, custom blinds, mail box, security system and deck screening.

The name of the owner or proprietor of the said property is Frontier Bank c/o Steven Townson 16863 Highway 280 Chelsea, AL 35043. Charles H. Fuller entered into a contract with Harry Horton d/b/a /HDH Construction where in Charles H. Fuller agreed to make certain improvements to the property. Harry Horton d/b/a /HDH Construction initially constructed the house and improved the land using the proceeds of a loan secured by a mortgage on the property issued by Frontier Bank. Harry Horton d/b/a /HDH Construction defaulted on the loan and Frontier Bank obtained title to the property through foreclosure. Charles H. Fuller has performed all conditions precedent under the contract, and has provided labor and materials for the improvement of said property, consistent with said contract of which Frontier Bank is the beneficiary of said improvements.


