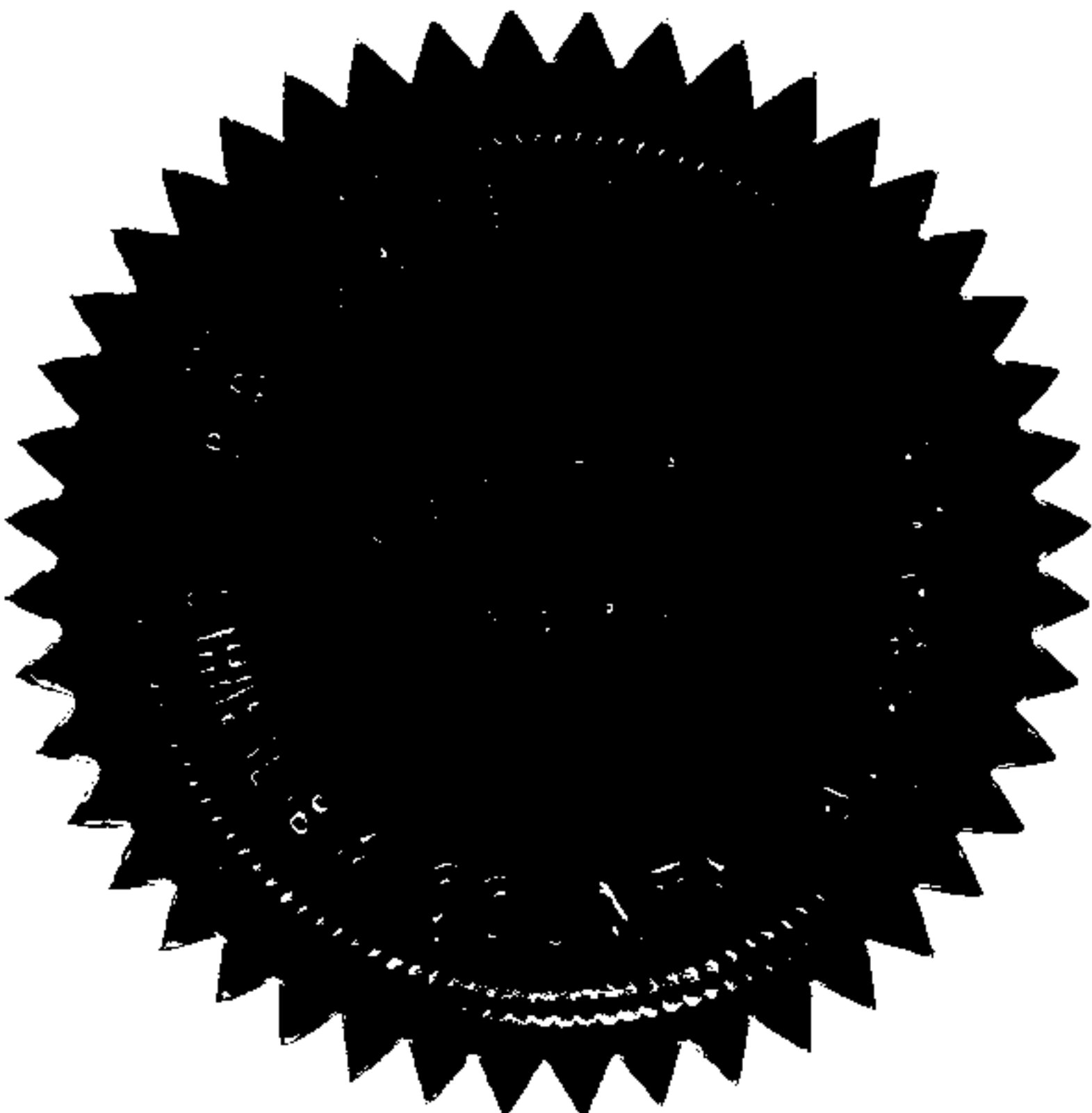


Certificate of Incorporation Amendment Of TIMBERLINE HOMEOWNERS' ASSOCIATION
