DELEGATION OF POWERS BY PARENT

That they are to be able to exercise and have power and control, over her education, residence, social, medicines, medical care and discipline as I might or could do if personally present.

It is my intention that the persons above named shall have all the powers heretofore stated, except the power to consent to marriage or adoption of my child. I further understand that this temporary delegation of my parental powers does not relieve me of the primary responsibility of caring for my child.

HEREBY GIVING AND GRANTING unto said person, full power and authority to do, take and perform all and every act and thing whatsoever deemed requisite, proper or necessary to be done, in the exercise of any of the rights and powers herein granted, as fully to all intents and purposes for the benefit of said child, as I might or could do if personally present, and hereby ratifying and confirming all that the said person shall lawfully do or cause to be done by virtue of this delegation of powers and the rights and powers herein granted.

This delegation of powers shall commence and be in full force and effect on the date set out herein below and shall remain in full force and effect until the end of the school year in 2011.


