KNOW ALL MEN BY THESE PRESENTS, THAT:

WHEREAS, heretofore on, to-wit: September 30, 2005, Wilbur H. Morlock And Jos Morlock, Husband And Wife, mortgagors, executed a certain mortgage to Compass Bank which said mortgage is recorded in Instrument # 20051003000512730, in the Office of the Judge of Probate of Shelby County, Alabama; and,
