KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 22nd day of September, 2006, Jason Johnsey and Kristi Johnsey, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for Accredited Home Lenders, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20061012000505780, said mortgage having subsequently been transferred and assigned to US Bank National Association, as Trustee for Asset-Backed Pass-Through Certificates Series 2007-AHL1, by instrument recorded in Instrument Number 20100521000159840, in the aforesaid Probate Office ("Transferee"); and

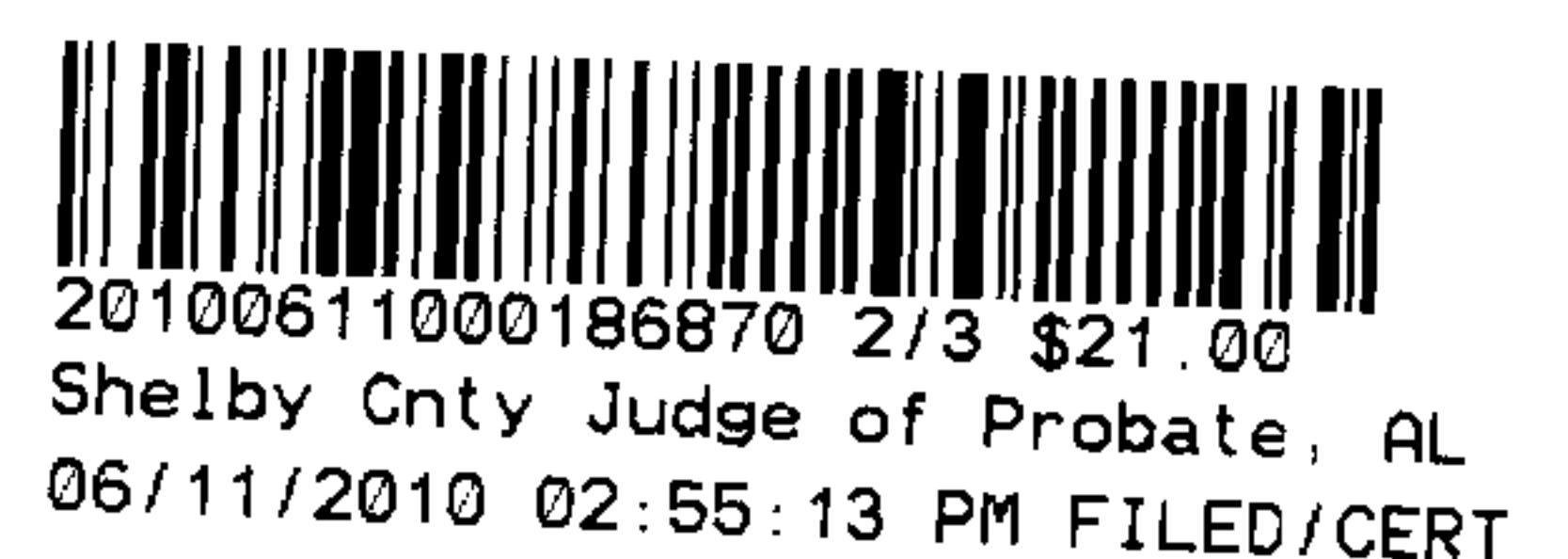
