
## ITEM II

## ITEM III

I futher authorize any of said named persons as may qualify hereunder to execute all necessary and proper conveyances, transfers, assignments or bills of sale, as might be required or become convenient in order to vest good, indefeasible title in the purchaser to whom they may sell, any part of my property. My said Executor shall be the sole judge of the price and terms of the sale and the discretion of either when so exercised shall not be subject to review of any court or courts whatsoever.
