Know All Men by These Presents: That in consideration of **Two hundred thirteen thousand seven hundred sixty and no/100 (\$213,760.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Buck Creek Construction, Inc.** (herein referred to as grantor, whether one or more), does hereby grant, bargain, sell and convey unto **Traci F. 
