ASSIGNMENT OF JUDGMENTS AND LIENS

WHEREAS, on March 25, 2010, Metal Building Components, Inc. (hereafter "MBCI") obtained a judgment against Union United Methodist Church (hereafter "Union") in the amount of \$26,607.86 in the case styled Metal Building Components, Inc. v. Double J Steel Enterprises, et al., Case No. CV09-900274, in the Circuit Court of Shelby County, Alabama; and

WHEREAS, on June 11, 2010, in the same case Union obtained judgments against Double J Steel Enterprises, Jeffrey G. Jones, and Deborah D. Jones (hereafter "Double J") in the amount of \$26,607.86 plus costs; and

WHEREAS, Union has recorded certificates of judgment for said amounts in the Probate Office of Chilton County, Alabama, in Book G 2010, pages 157632, 157633, and 157634, copies of which are attached hereto; and

WHEREAS, MBCI and Union have agreed that Union will assign its said judgments and recorded liens to MBCI in full satisfaction of MBCI's judgment against Union described above;

NOW, THEREFORE, premises considered, and in consideration of the full satisfaction and release of MBCI's judgment against Union described above, Union assigns to MBCI its judgments and liens against Double J as described above, and any and all sum or sums of money or other benefit or advantage which may be had or obtained by reason of such judgments and liens. Union warrants to MBCI that it has not received or collected any sums whatsoever on said judgments or liens, and has not taken any actions to enforce or collect such judgments or liens other than to record the certificates of judgment as aforesaid. Union agrees that it will not collect or receive the same,

or any part thereof, nor release or discharge the judgments or liens, but will allow all lawful proceedings in the same. Union does not warrant the collectibility or the judgments or liens or the solvency of Double J, and this assignment is without recourse against Union.


