KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 19th day of July, 2002, Shannon DeBlieck, and her husband, Thomas Wayne DeBlieck, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for AEGIS Mortgage Corporation d/b/a New America Financial, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20020731000355390, said mortgage having subsequently been transferred and assigned to Aurora Loan Services, LLC, by instrument recorded in Instrument No. 20090128000026830, in the aforesaid Probate Office ("Transferee"); and
