AFFIDAVIT OF REVAPEELER HESTER

Before me the undersigned, a Notary Public in and for said County and State, personally appeared Reva Peeler Hester in this cause who is known to me and who by me first being duly sworn deposes and says as follows:

My name is Reva Peeler Hester and I am the Plaintiff in the above referenced case. On September 22, 2003, I executed a Power of Attorney to John Clinton Landman, Jr., my grandson. He accessed funds from my home equity line of credit over the next six years amounting to over forty five thousand dollars. Some of the checks were without my knowledge. From the time he got the Power of Attorney, he or his mother made the payments on the equity line. Around December of 2009, he stopped paying anything on the equity line and as a result the account has gone into default and the account is in pre-foreclosure status with Regions Bank. The current balance on the equity line is \$46,413.51. I am asking this Court for damages in that amount, plus three thousand five hundred dollars (\$3,500) in attorney fees, and three hundred dollars (\$300.00) for Court costs-

The statements made in my Affidavit are true and correct.


This cause came before the Court on a Complaint for Fraud, Breach of Fiduciary Duty and Negligence. The Defendant John Clinton Landman, Jr. was served on May 5, 2010 and failed to answer or defend himself against the Complaint within thirty days. The Plaintiff made an entry of Default and upon the Damage Affidavit of the Plaintiff the Court finds as follows;

Judgment shall be entered against Defendant John Clinton Landman, Jr. and in favor of the Plaintiff Reva Peeler Hester, in the amount of forty-six thousand four hundred thirteen dollars and fifty-one cents (\$46,413.51) for compensatory damages, and against Defendant John Clinton Landman, Jr. and in favor of the Plaintiff Reva Peeler Hester in the amount of three-thousand five-hundred dollars (\$3,500.00) for attorney fees, and against the Defendant John Clinton Landman, Jr. and in favor of Plaintiff Reva Peeler Hester the amount of three hundred dollars (\$300.00) in costs, for a total judgment of fifty-thousand two hundred thirteen dollars and fifty-one cents (\$50,213.51).


