## WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

That in consideration of **Three Hundred Eight Thousand and 00/100 Dollars (\$308,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

**David E. Phillips** and his wife **Lee Ann Phillips**

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

**Barton J. Archer** and **Sara Kerr Archer**

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

**Lot 2719, according to the Survey of Riverchase Country Club 27th Addition, as recorded in Map Book 11, Page 56 A & B, in the Probate Office of Shelby County, Alabama.**

\$246,400.00 of the proceeds come from a mortgage recorded simultaneously herewith.

\$15,400.00 of the proceeds come from a second mortgage recorded simultaneously herewith

Subject to:         (1)     2011 ad valorem taxes not yet due and payable;
