**ARTICLES OF INCORPORATION**

**ARTICLE II**

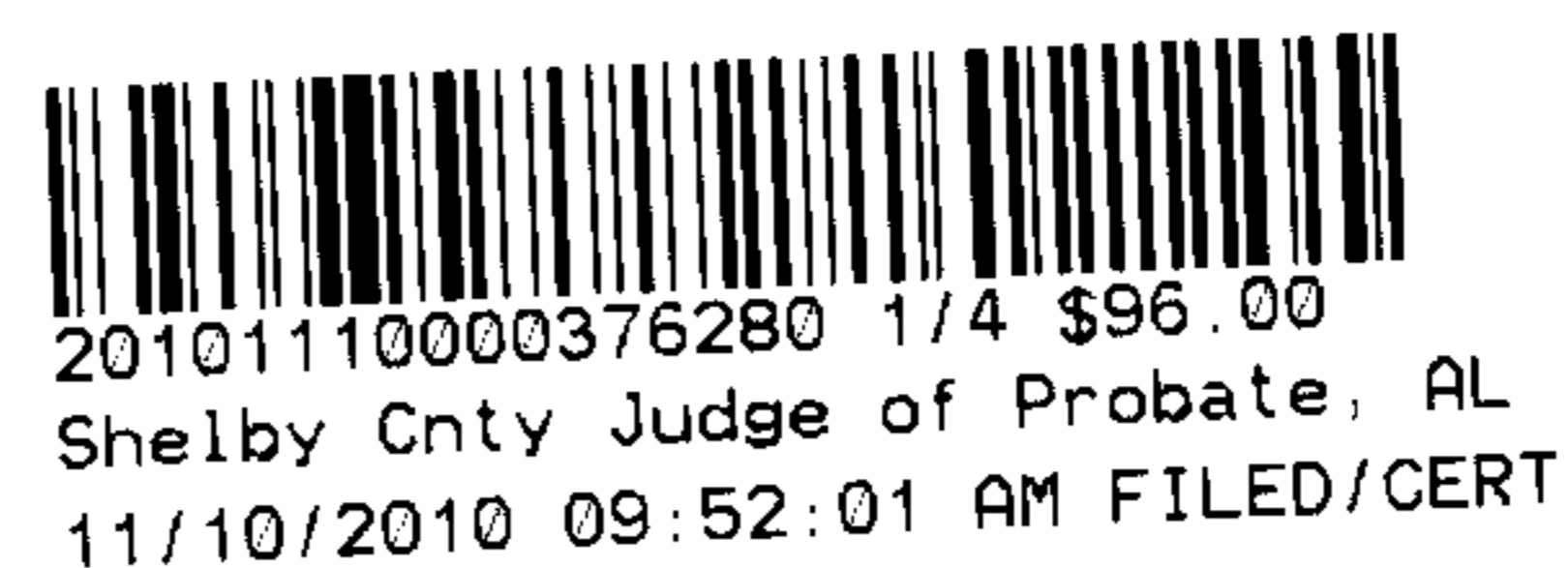
**Duration.** The duration of the corporation shall be perpetual.

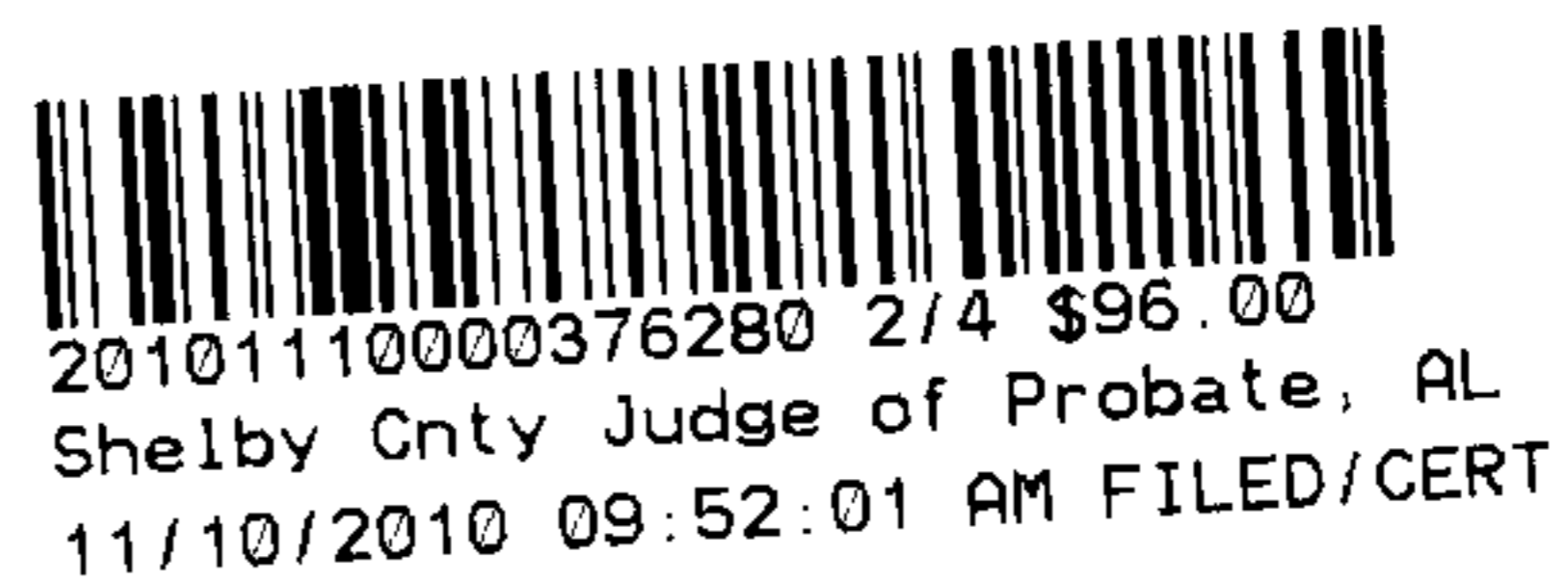
