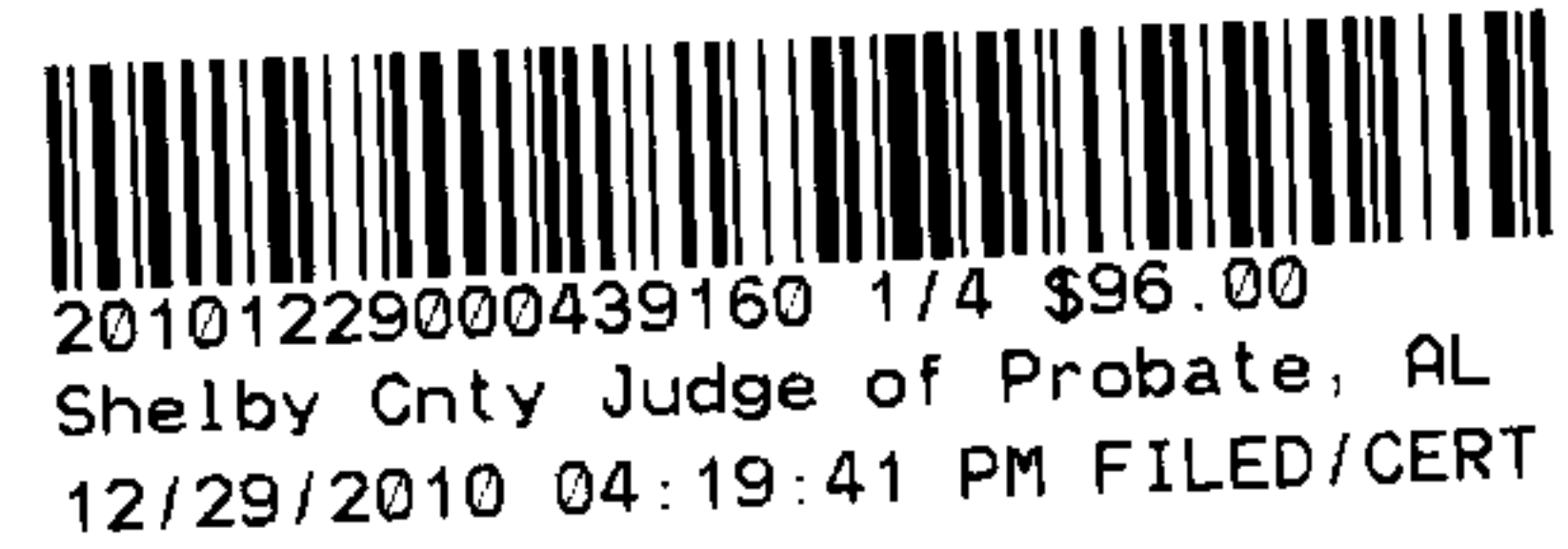


**ARTICLES OF INCORPORATION  
OF  
GAYLARD ENTERPRISES, INC.**



The undersigned, acting as Incorporator of a corporation under the *Code of Alabama* (1975), adopts the following Articles of Incorporation for such entity:

(1) NAME OF CORPORATION and DURATION: The name of the corporation shall be **Gaylard Enterprises, Inc.**, and the period of its duration shall be perpetual.

(2) PURPOSE: The objects and purposes for which the corporation is formed are:

- (a) To engage in graphic design;
- (b) To enter into, make and perform contracts and agreements of every kind for any lawful purpose, with any person, firm, corporation, municipality, or political body, whether related to the business purpose stated in Paragraph (a) above or not, and generally to carry on any and every lawful business which a corporation is permitted to do by the Constitution and laws of the State of Alabama; and such other business shall not be limited to the State of Alabama; and

- (c) In furtherance and not in limitation of the aforesaid objects, to carry on any lawful business, to sell all types of goods and perform all types of services, and to do anything convenient in connection with the carrying on of such business; and to do business without any restrictions in any legal business in the State of Alabama, or any other state of the United States, and to own, buy and sell personal property and to borrow money and issue its bonds, notes or mortgages therefor.

(3) INITIAL REGISTERED OFFICE AND AGENT: The address of the initial registered office of the corporation is 114 Trade Center Drive, Suite D, Pelham, Alabama, 35244, and the name of its initial registered agent at such address is Derek Gaylard.

(4) STOCK: The amount of initial authorized capital stock of the corporation shall be

fixed at \$1,000, divided into 1,000 shares of common stock of the par value of \$1.00 per share. The amount of capital stock with which the corporation will begin business is 1,000 shares of common stock of the par value of \$1.00 per share. There shall be only one class of stock.

(5) The name and address of the agent designated by the Incorporator to receive subscriptions to the capital stock of the corporation is Derek Gaylard, 114 Trade Center Drive, Suite D, Pelham, Alabama, 35244.

(6) BOARD OF DIRECTORS: The number of Directors constituting the initial Board of Directors of the Corporation is one, and the name and address of the person who is to serve as Director until the first meeting of Shareholders or until successors are elected and qualified is:

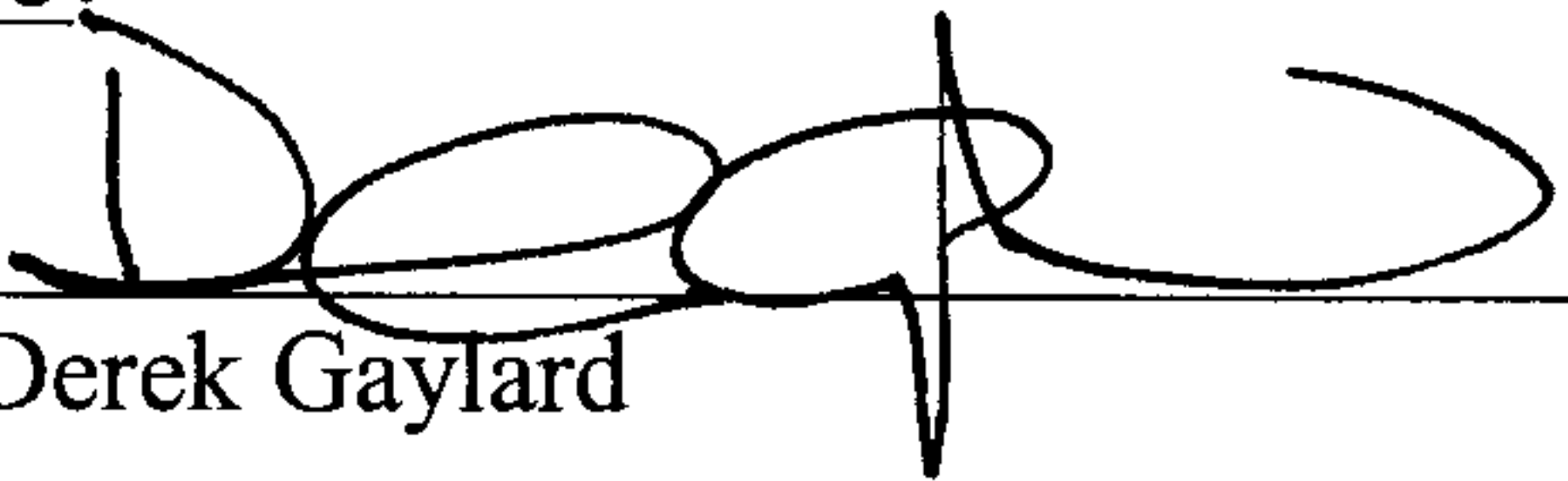
(7) INCORPORATORS: The name and post office address of the initial Incorporator and the number of shares of stock subscribed for by him are as follows:

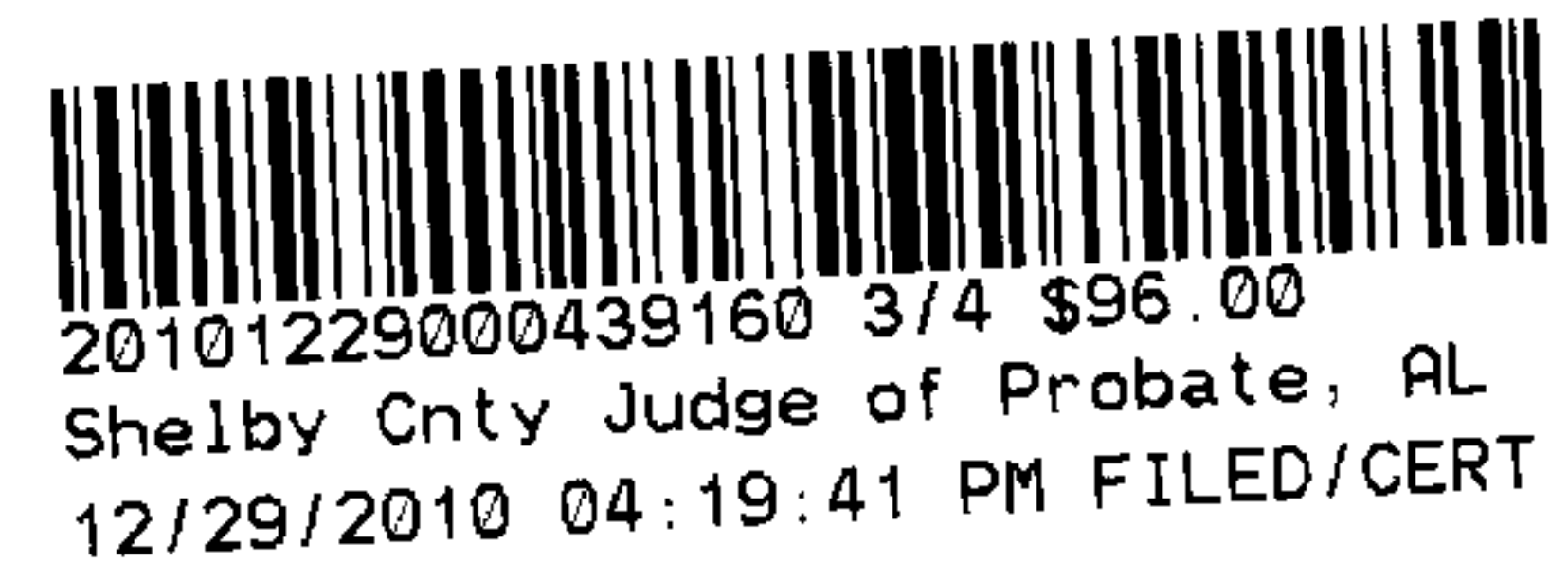
(8) BYLAWS: The shareholder shall have the authority to adopt Bylaws of the Corporation, and the power to alter, amend, or repeal the Bylaws and to adopt new Bylaws. The Bylaws shall contain provisions for the regulation and management of the affairs of the Corporation not inconsistent with law or these Articles of Incorporation.

(9) AMENDMENTS: All provisions of these Articles of Incorporation shall be subject to amendment by affirmative vote of three quarters of the shareholders.

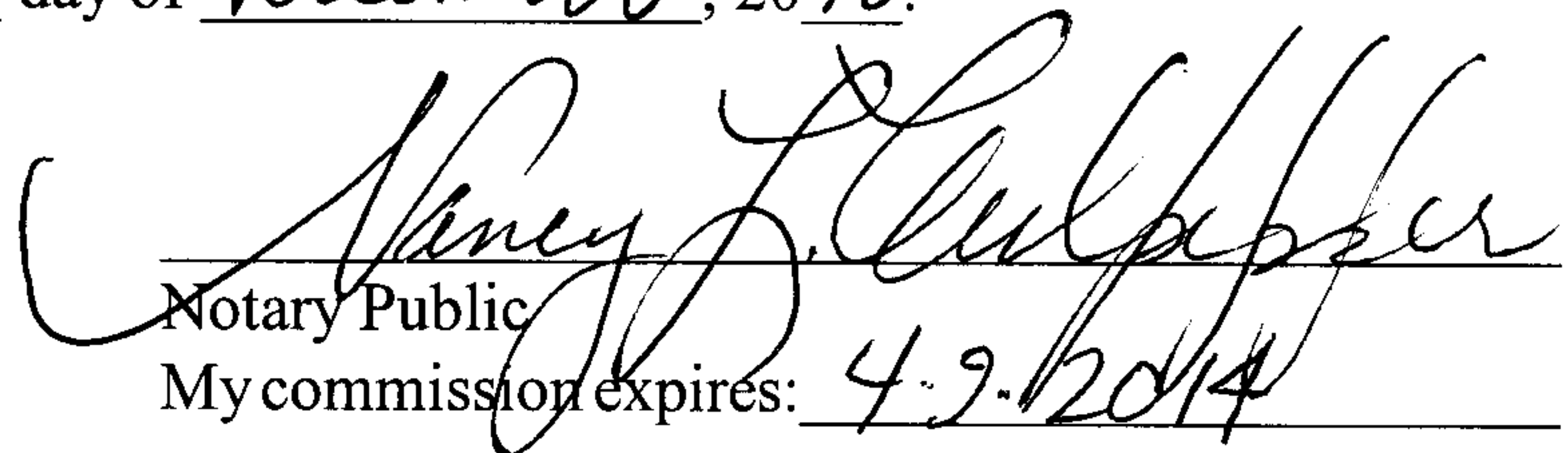
