**PREAMBLE:** This is a MILITARY POWER OF ATTORNEY prepared pursuant to Title 10, United States Code. §1044b, and executed by a person authorized to receive legal assistance from the military services. Federal law exempts this power of attorney from any requirement of form, substance, formality, or recording that is prescribed for powers of attorney by the laws of a state, the District of Columbia, or a territory, commonwealth, or possession of the United States. Federal law specifies that this power of attorney shall be given the same legal effect as a power of attorney prepared and executed in accordance with the laws of the jurisdiction where it is presented.

**KNOW ALL PERSONS:** That I, AMANDA MURPHY STORIE (“Grantor” or “Principal”), currently residing at PO BOX 9906 CHESAPEAKE, VA 23321 by this document do make and appoint CHRISTOPHER TODD STORIE (“Grantee”, “Agent” or “Attorney in Fact”), whose address is 153 CREST DRIVE WESTOVER, AL 35147 as my true and lawful attorney-in-fact to act as follows, GRANTING unto my said Attorney full power to do and perform any and all acts necessary or appropriate to maintain my property located at 153 CREST DRIVE WESTOVER, AL 35147. This is to include making minor repairs and conduct general maintenance on said property and also to charge adequate fee and/or rent; make minor repairs and conduct general maintenance on said property; to enforce any and all lawful rights and claims I may have against any former, present, future tenant or lessee thereof and to eject or remove tenants or other persons from and recover possession of such property by all lawful means; to enforce any and all lawful rights and claims I may have against any former, present, future tenant or lessee thereof and to eject or remove tenants or other persons from and recover possession of such property by all lawful means. And further, that my said agent is required and empowered to enter into a lease on my behalf for said premises, subject to such terms and conditions as I may hereinafter describe.

**TERMINATION:** This power shall remain in full force and effect until 28 FEB 2011, unless sooner revoked or terminated by me.

Notwithstanding my insertion of a specific expiration date herein, if on the above specified expiration date I shall be, or have been, carried in a military status of "missing", "missing-in-action" or "prisoner of war", then





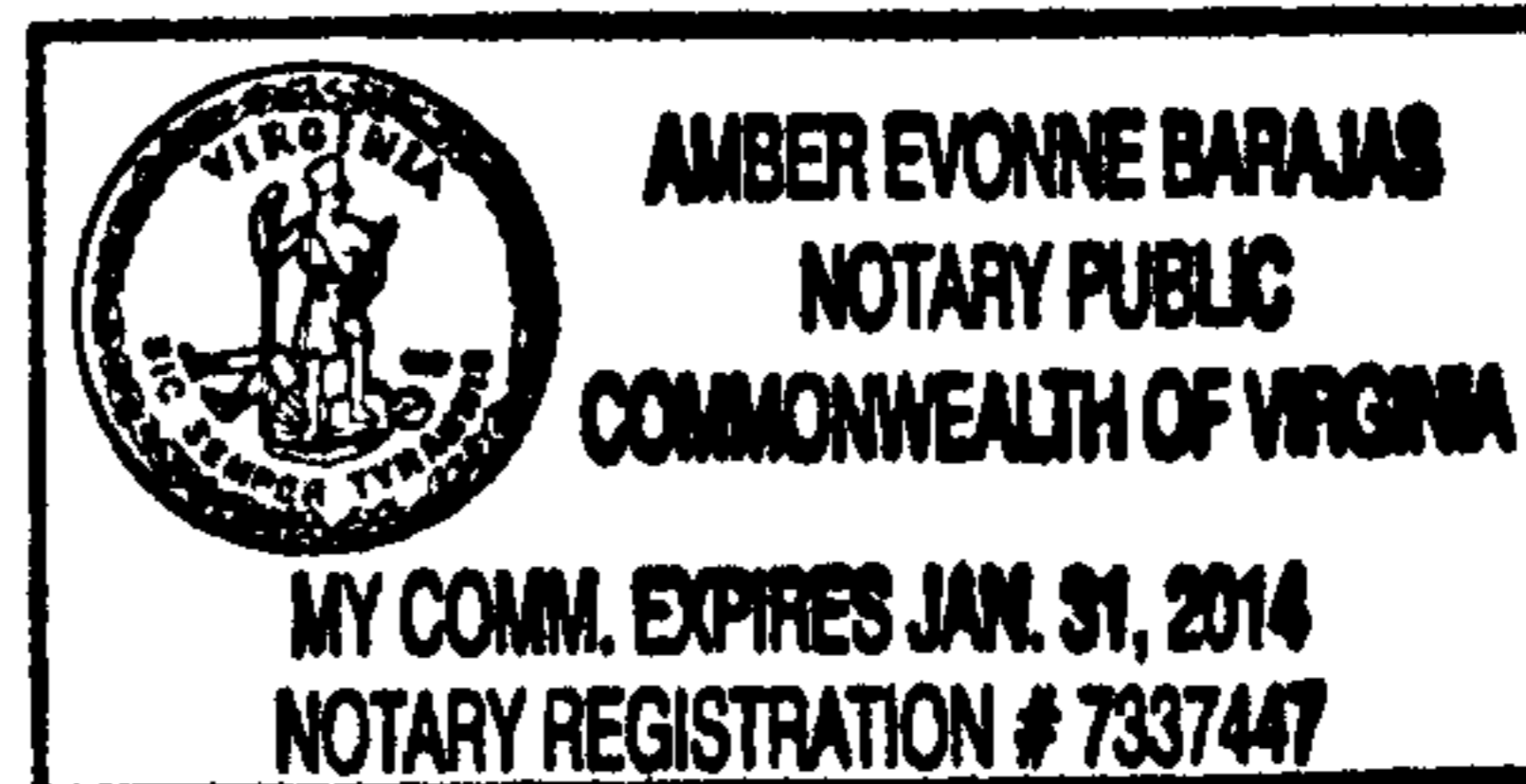
