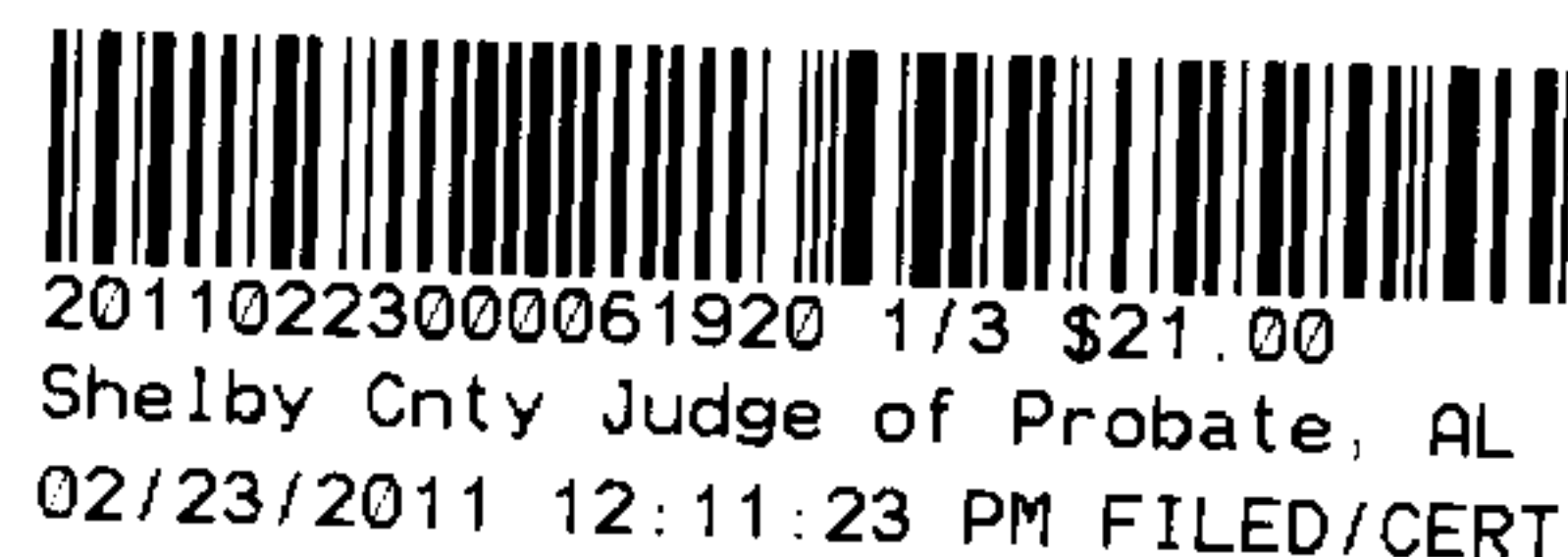
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 5th day of March, 1998, William E. Rowland and Karen M. Rowland, husband and wife, executed that certain mortgage on real property hereinafter described to Norwest Mortgage, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 1998-09009, and


