KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 1st day of March, 2004, Robin Kidd and Brad Kidd, her spouse, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for HMSV-USB Lending, LLC DBA MortgageSouth, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. # 20040304000111930, said mortgage having subsequently been transferred and assigned to U.S. Bank, National Association, by instrument recorded in Instrument # 20100920000308220, in the aforesaid Probate Office ("Transferee"); and




