

ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Alabama Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE ONE

NAME

ARTICLE TWO

DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE


PURPOSE

The purposes for which the corporation is organized are to engage in the delivery of goods and products to various entities as well as engage in any business necessary to facilitate the transportation and relocation of goods and products; and to engage in any lawful act or activity for which corporations may be organized under the Alabama Business Corporation Act.

ARTICLE FOUR

REGISTERED OFFICE



ARTICLE EIGHT

POWERS


