FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 30th day of November, 2004, Jannie S Allen and Michael E. Allen, wife and husband, executed that certain mortgage on real property hereinafter described to Mortgage Professionals, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20041203000661570, said mortgage having subsequently been transferred and assigned to Regions Bank DBA Regions Mortgage, by instrument recorded in Instrument Number 20100329000091200, in the aforesaid Probate Office ("Mortgagee"); and

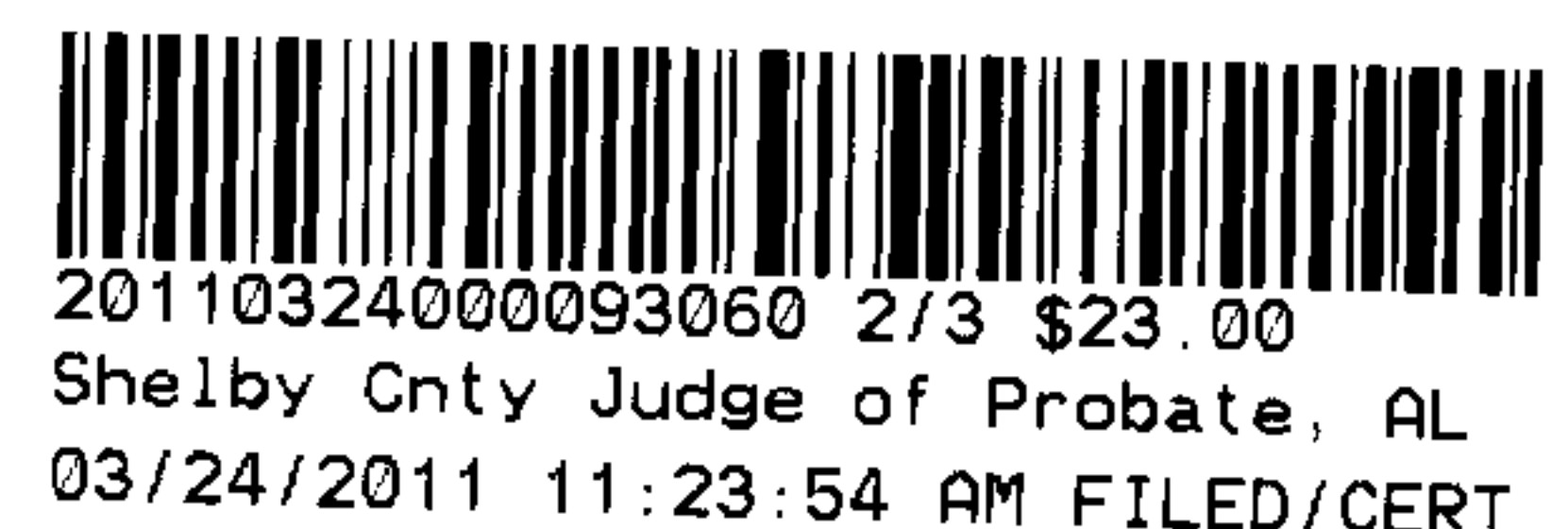
