

ARTICLES OF ORGANIZATION

OF

FIXIT, LLC

TO THE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

Pursuant to the provisions of the Alabama Limited Liability Company Act (hereinafter referred to as "the act"), the undersigned hereby adapts the following Limited Liability Company Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company ("Company") is FIXIT, LLC

ARTICLE II

DURATION

The period of duration for the company shall be from the date of filings these Articles of Organization with the Office of the Judge of Probate of Shelby County, Alabama (the "The Fillings Date"), until the earliest to occur the following:

- A. The fiftieth (50th) anniversary of the filing Date;
- B. Dissolution of the company by the unanimous written agreement of the sole member; or
- C. The occurrence of an event which the Act constitutes an event of dissolution or otherwise works a termination of the Company under the Act, unless the legal existence and business of the Company are continued pursuant to Article VII below.

ARTICLE III

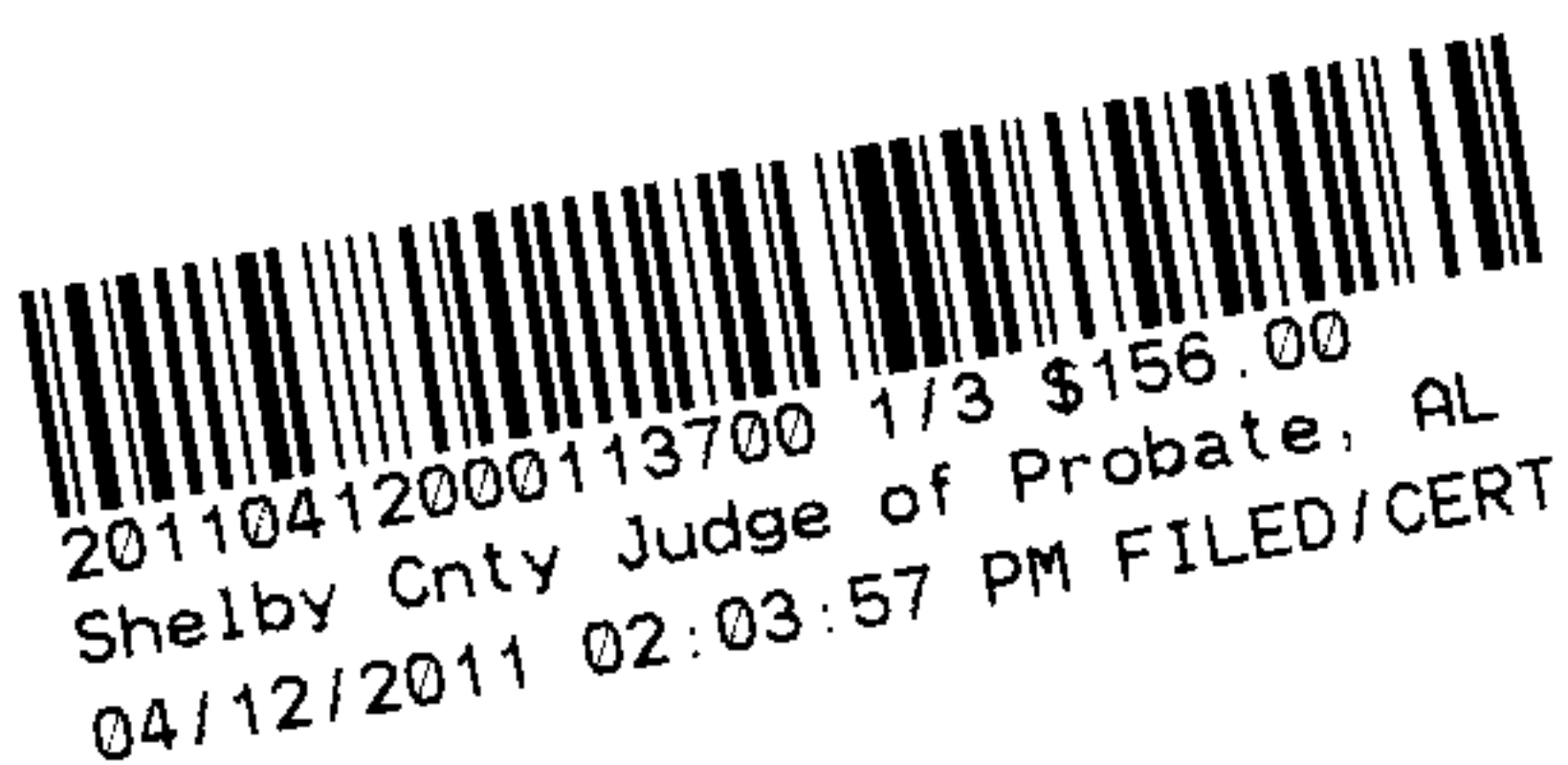
PURPOSES

The company has been organized for the following purposes:

- (1) The following but not limited to: Advertising, marketing, selling and repairing.
- (2) For the lawful purpose or purposes for which a Limited Liability Company may be organized under the laws of the State of Alabama.

ARTICLE IV

INITIAL REGISTERED OFFICE AND INITIAL REGISTERED AGENT

ADMISSION OF NEW MEMBERS

The sole member of the company shall have the right to admit new members from time to time. In the event the sole member has admitted new members, the rights of the sole member will stay the same.

ARTICLE VII

CESSATION OF MEMBERS

The cessation of membership of one or more members will not result in the dissolution of the company.

ARTICLE VIII

MANAGEMENT


The Company shall be managed by its sole member. In the event that additional members are admitted pursuant to Article VI, the sole member will still be the managing member.
